PROPOSED ORDER

The Motion for Approval of Representative Action Settlement ("Motion") came before this Court, the Honorable Esmeralda Zendejas, presiding. The Court, having considered the papers submitted in support of the motion of the parties, **HEREBY ORDERS THE FOLLOWING:**

Having considered Plaintiff's Motion, and all legal authorities and documents submitted in support thereof, including the PAGA Settlement Agreement ("Agreement" or "Settlement"), attached to the Szamet Declaration as Exhibit "1", and good cause appearing, IT IS HEREBY ORDERED that Plaintiff's Motion is GRANTED, subject to the following findings and orders:

1. The Court finds the Settlement is fair and reasonable.
2. The Court approves the Gross Settlement Amount of \$100,000.00.
3. The Court approves the PAGA Penalties in the amount of \$48,061.09.
4. The Court approves 75% of the PAGA Penalties being allocated to the LWDA in the amount of \$36,045.82.
5. The Court directs that the remaining 25% of the PAGA Penalties, in the amount of \$12,015.27 shall be allocated to Individual PAGA Payments.
6. The Court approves the PAGA Counsel Fees Payment of not more than 35% of the Gross Settlement Amount, in the amount of \$35,000.00.
7. The Court approves PAGA Counsel's request for reimbursement of case costs of \$8,988.91.
8. The Court approves the settlement administration costs of \$2,950.00.
9. The Court approves an enhancement payment to Plaintiff Robert Mark-Waterhouse of \$5,000.00.
10. The Parties are ordered to carry out the terms of the Agreement.
11. Pursuant to C.C.P §664.6, the Court shall have and retain continuing jurisdiction over this action and the Parties and the PAGA Members including after the entry of this Order, to the fullest extent necessary to interpret, enforce and effectuate the terms and intent of the Settlement Agreement and this Order.

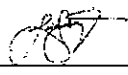
