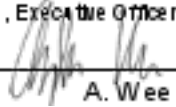

The Court has received and considered the proposed PAGA Settlement Agreement (the “PAGA Settlement”) between Plaintiffs Ilana Pearlman, Sallie Hill, Sonya Jubb, Diana Nemirovsky, Jessica Izquierdo, Lior Bloom, and Alison Roberts (“PAGA Plaintiffs”), on behalf of the people of the State of California and as “Aggrieved Employees” acting as private attorneys general under the Labor Code Private Attorneys General Act of 2004, § 2699, *et seq.* (“PAGA”) and Defendants Sutter East Bay Medical Group, Inc., Sutter Health, Sutter Bay Medical Foundation, and The Surgery Center of Alta Bates Summit Medical Center, LLC (collectively “Defendants”) in the above-captioned action.

NOW THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED:

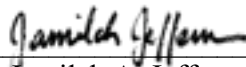
The Court APPROVES the PAGA Settlement and hereby enters FINAL JUDGMENT on the PAGA claims based on the terms set forth in the PAGA Settlement and Memorandum of Points and Authorities in Support of Plaintiffs’ Motion for Approval of PAGA Settlement in favor of PAGA Plaintiffs in the amount of \$15,000.00, 75 percent of which (\$11,250) shall be paid to the Labor and Workforce Development Agency and 25 percent of which (\$3,750.00) shall be paid to PAGA Plaintiffs as Aggrieved Employees.

The claims asserted by all named Plaintiffs (including non-PAGA Plaintiff Tiffany Lundeen) in this action are **DISMISSED WITH PREJUDICE**. The claims asserted under PAGA on behalf of all other alleged aggrieved employees who are not named Plaintiffs are **DISMISSED WITHOUT PREJUDICE**.

The Court retains jurisdiction of all matters relating to the interpretation, administration, implementation, effectuation, and enforcement of the PAGA Settlement pursuant to C.C.P. § 664.6.

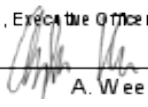
