[PROPOSED] ORDER

Under Labor Code section 2699(1)(2) of the Private Attorneys General Act of 2004 ("PAGA"), the Motion of Plaintiff Grimmer Bran ("Plaintiff") for Approval of Settlement under PAGA came before this Court on December 24, 2025 at 8:30am.

Plaintiff's Complaint seeks civil penalties on behalf of the State of California and similarly situated aggrieved employees (the "Aggrieved Employees"), as authorized by PAGA under Labor Code § 2699, in relation to alleged violations of the predicate statutes set forth in Plaintiff's Complaint and the letter to the Labor Workforce and Development Agency "LWDA") dated April 12, 2024 (the "LWDA Letter"), on behalf of all current and former non-exempt employees of Defendants from April 12, 2023 through March 11, 2025, inclusive.

Under PAGA, in any action brought by an aggrieved employee, the Court "shall review and approve any settlement of any civil action filed pursuant to this part." Lab. Code § 2699(1)(2). Accordingly, the Court, having considered the proposed settlement set forth in the Settlement Agreement, including the proposed PAGA penalties, under Labor Code § 2699(1)(2), having considered the papers filed in support of the proposed settlement and the arguments of counsel, and good cause appearing, HEREBY ORDERS AS FOLLOWS:

1. The Court finds the instant Action presents a good faith dispute of the claims alleged;

2. The Court finds in favor of settlement approval, and therefore approves the Settlement of the above-captioned action, as set forth in the Settlement Agreement and each of the releases and other terms, as fair, just, reasonable, and adequate;

3. The Court finds further that Plaintiff, acting on behalf of himself and the State of California, by operation of this Order and Judgment hereby releases and forever discharges Defendants and the Released Parties (as defined in the Settlement Agreement) from any and all PAGA Released Claims (as defined in the Settlement Agreement) including penalties asserted in Plaintiff's Complaint, including any and all known and unknown claims for civil penalties under the Private Attorneys General Act, California Labor Code §§ 2698, *et seq.*, that arise.

1 4. The Court finds further that the foregoing release shall be binding on Plaintiff and the
2 State of California and shall bar any claim under PAGA brought by any person, including the Aggrieved
3 Employees, on behalf of the State of California, as to the PAGA Released Claims and Released Parties.
4 Furthermore, no individualized notice of entry of this Approval Order is required to be provided to the
5 PAGA employees.

6 5. The Parties are directed to comply with all terms of the Settlement Agreement, and
7 Defendants are directed to make all payments required by the Settlement Agreement;

8 6. Under the Settlement Agreement, Defendants TIFERET COMPANY, INC.;
9 STEVEN LEANSE; and ROBIN LEANSE agree to pay an all-in gross amount of Two Hundred
10 Eighty-Seven Thousand Three-Hundred Fifty Dollars and Zero Cents (\$287,350.00) (the "Gross
11 Settlement Amount"). The Gross Settlement Amount is inclusive of payments to the LWDA and
12 Aggrieved Employees, Attorney's Fees and Costs, and PAGA settlement administration costs. No
13 portion of the Gross Settlement Amount will revert to Defendants. Plaintiff's Counsel requests an award
14 of attorney's fees of Ninety-Five Thousand Seven Hundred Eighty-Three Dollars and Thirty-Three
15 Cents (\$95,783.33); costs of Seven Thousand Seven Hundred Thirty Dollars and Eighty-Four Cents
16 (\$7,730.84). The settlement administrator, Apex Class Action Administration requests administration
17 costs of Three Thousand Nine Hundred Ninety Dollars and Zero Cents (\$3,990.00). Defendants do not
18 oppose these requests. The Court finds the Gross Settlement Amount is fair, reasonable and adequate,
19 and approves each of these payments, and directs the Settlement Administrator to make the above
20 payments to payments from the Gross Settlement Amount as follows:

23 a. \$95,783.33 in attorney's fees to Messrelian Law Inc.;
24 b. \$7,730.84 in costs to Messrelian Law Inc.;
25 c. \$3,990.00 in administration costs to Apex Class Action Administration
26 d. After deducting the foregoing payments, the estimated remainder of approximately
27 \$179,845.83 shall form the Net Settlement Amount ("NSA"). Pursuant to Labor Code section
28 2699(i), the NSA will then be distributed 75 percent (\$134,884.37) to the LWDA, and the
remaining 25 percent (\$44,961.46) to the Aggrieved Employees on a pro rata basis, as set forth

1 in the Settlement Agreement. The Court approves these payments, and directs the Settlement
2 Administrator to issue checks to the LWDA and Aggrieved Employees, along with the Notice
3 of PAGA Settlement, as set forth in the Settlement Agreement, and to otherwise carry out its
4 duties as set forth in the Settlement Agreement; and

5 7. The entire Action is hereby DISMISSED WITH PREJUDICE as to all parties and all
6 causes of action. The Court reserves exclusive and continuing jurisdiction over the Action and the Parties
7 under Code of Civil Procedure§ 664.6 for the purpose of supervising implementation, enforcement,
8 construction, administration, and interpretation of the Settlement Agreement.
