Plaintiffs Cheryl A. Gerrish and Shenika Akins ("Plaintiffs") and Defendant Orange County's Credit Union ("Defendant") (collectively, the "Parties") have reached a settlement of the above-captioned matter (the "Action"). Pursuant to the California Private Attorneys General Act of 2004, Labor Code sections 2698, *et seq.* ("PAGA"), Plaintiffs have filed a Motion for Approval of PAGA Settlement ("Plaintiffs' Motion") seeking approval of the Parties' PAGA Settlement Agreement (the "Settlement"). A true and correct copy of the Settlement is attached as **Exhibit 1** to the Declaration of Kane Moon in Support of Plaintiffs' Motion for Approval of PAGA Settlement ("Moon Decl.").

The Court, having duly considered Plaintiffs' Motion, the supporting declarations and exhibits thereto, including the Settlement, all other papers filed and proceedings had herein, and having reviewed the record in this Action, and good cause appearing, **HEREBY ADJUDGES AND DECREES AS FOLLOWS:**

1. The Court has granted Plaintiffs' Motion by way of an Order Granting Motion for Approval of PAGA Settlement (the "PAGA Approval Order"). The PAGA Approval Order is incorporated herein in its entirety.

2. The Court now enters Judgment. The Judgment set forth herein is intended to be a final disposition of the Action in its entirety and is intended to be immediately appealable. All capitalized terms used for purposes of this Judgment have the same meaning as given in the Settlement, unless otherwise indicated.

3. In accordance with and for the reasons stated in the PAGA Approval Order, this Judgment is entered whereby Plaintiffs, PAGA Counsel, the California Labor and Workforce Development Agency (the "LWDA"), and the Aggrieved Employees, shall take nothing from Defendant for the PAGA claims alleged in this Action, except as expressly set forth in the PAGA Settlement.

4. All payments due by Defendant under the Settlement will be made pursuant to the Settlement, the PAGA Approval Order, and this Judgment.

5. ~~Based on the foregoing and in accordance with the Settlement, this Action is DISMISSED WITH PREJUDICE.~~

6. Each side is to bear its own costs and attorneys' fees with respect to the PAGA claims alleged

1 in this Action, except as provided by the Settlement, the PAGA Approval Order, and this Judgment.

2 7. Pursuant to California Code of Civil Procedure section 664.6 and notwithstanding entry of
3 the PAGA Approval Order or this Judgment, the Court shall retain jurisdiction over the Parties, Action, and
4 the Settlement solely for purposes of addressing: (i) the interpretation and enforcement of the terms of the
5 Settlement, (ii) settlement administration matters, and (iii) such post-Judgment matters as may be appropriate
6 under court rules or as set forth in the Settlement.
