DECLARATION OF JAVIER HERNANDEZ

I, JAVIER HERNANDEZ, declare as follows:

1. I am a named Plaintiff in this case as an employee of the named defendant PRECISE AEROSPACE MANUFACTURING, INC. ("Defendant"). As such, I have personal knowledge of, or am informed and believe, the following facts herein stated. If called as a witness. I could and would testify competently to the following:

JOB DUTIES AND EXPERIENCES

2. I worked for Defendant during the Class Period as an hourly-paid non-exempt employee from June 15, 2023 to April 3, 2024. I was paid on hourly basis and classified as non-exempt from overtime. Throughout my employment, I typically worked 5 days per workweek, and typically in excess of 8 hours in a workday.

3. While working for Defendant, I did not receive all meal and rest periods. I was required to work off-the-clock without compensation and my working time was rounded. While working for Defendant, I was also not reimbursed for work related expenses.

DUTIES OF A CLASS REPRESENTATIVE

4. This lawsuit is not an individual lawsuit. It is a proposed class action. I understand that, if approved as a class representative in this matter, I have an obligation to do my best to look out for the interests of other class members, the current and former employees of Defendant who I am seeking to represent. I understand that my obligations to the class exist even when the class is certified solely as part of a class action settlement. It is my understanding that, as one part of this duty to the class, I cannot agree to a settlement to benefit myself to the exclusion of the rest of the class members. I have never asked my attorneys to simply settle this matter at any cost. Rather, I have asked them to obtain the best settlement they could within reason, and I believe that they have attempted to do so.

5. I have been actively involved in this case since I first retained Tunyan Law, APC. I have never asked to be relieved from my role as a proposed class representative. To the contrary, I have made myself available whenever my attorneys wanted to discuss aspects of my employment at Defendant, and I remain committed to seeing this matter through to the end.

6. I have conferred with my attorneys about the settlement proposed in this case. I am not an

1 accountant, but I understand the factors and risks that need to be considered when evaluating a
2 settlement. I believe that the Class Action Settlement obtained on behalf of the Class Members is fair and
3 reasonable in view of the issues and risks involved with the case.

4 7. I am asking to be stand-in for other employees of Defendant. Because of that, I cannot
5 quit on the Class, and I cannot put myself and my interests before the Class. I accept these duties and
6 request that I be approved as the class representative for purposes of this Settlement.

7 COMMUNITY OF INTEREST: TYPICALITY AND ADEQUACY

8 8. I was an hourly non-exempt employee of Defendant and was subject to the same pay structure
9 and rules as all the other hourly non-exempt employees of Defendant.

10 9. I am not aware of anything special about me that would raise unique defenses to my claims, as
11 opposed to the claims of the class. I am also not suing for anything unique to me. Rather, my claims are
12 based upon the same facts that relate to the rest of the Class.

13 10. I do not believe that I have any conflicts with Class Members included in this proposed
14 Settlement. I do not have any intention to take any action that would place me in a position that is
15 hostile to other Class Members.

16 SERVICE AS A CLASS REPRESENTATIVE

17 11. I believe if not for my stepping forward and taking on the duties of protecting the
18 interests all aggrieved former and current employees of Defendant, it is likely that the interests of the
19 Class would neither have been prosecuted, nor benefited. To my knowledge, other than the litigation
20 encompassed by this proposed Settlement, there is no other litigation concerning the class claims in this
21 lawsuit nor has Defendant pointed to any.

22 12. I have assumed some long-lasting risk in prosecuting this case. Because it is so easy to
23 search for information online these days, I will face an increased risk that future employers will
24 discover information about this lawsuit online and have a negative reaction to learning that I sued an
25 employer. This may make it harder for me to obtain future employment or change jobs for a better
26 opportunity.

27 13. I have devoted a substantial amount of my time, both before this lawsuit was filed and
28 also during its litigation, to ensure a fair result for the employee Class. This involved ongoing

1 communication and participation with my Counsel during the course of this case. My participation
2 began with bringing certain issues that are involved in this matter to my Counsel's attention and
3 explaining the factual background that was used to prosecute the claims in this case. For example, I
4 reviewed documents which I already had, I provided relevant documents to my Counsel, and I
5 explained those documents and related facts to my Counsel to assist them in their review during
6 multiple meetings with my attorneys.

7 14. My efforts continued after the suit was filed. For example, I have had many discussions
8 with the attorneys at Tunyan Law, APC regarding Defendant's wage and hour policies, my claims in
9 this case, litigation strategy, potential witnesses, discovery, updates on how the case was proceeding,
10 and how I could help the case. I also discussed strategy with my Counsel. I remained in regular
11 communication with my attorneys regarding discovery and settlement discussions that the parties had
12 during the course of litigation and mediation. I continued to identify employees and other witnesses to
13 counsel, along with other information as to how they could be of potential use in this matter. I also
14 provided substantial information and documents to my attorneys to assist them in preparing the case.

15 15. After the mediation, a long-form settlement agreement was negotiated, and I reviewed it
16 with my Counsel to ensure that its terms are likewise fair and adequate.

17 16. I believe that the Class Representative Service Payment of \$7,500 for me is fair and
18 reasonable. This enhancement takes into consideration the time, effort, risks, stress, and sacrifice of
19 signing a general release of all claims over just wage and hour claims, as well as the benefit provided to
20 all class members as a result of my involvement in this litigation. In sum, in addition to assuming the
21 risks that go along with being a class representative and named plaintiff in litigation, I believe I have
22 also provided well over 25 hours of my time during the course of this litigation to ensure a good
23 outcome for the best interests of the Class. I believe I have been diligent and acted above and beyond
24 that which is expected of a Class Representative throughout all stages of the litigation. I will continue to
25 diligently act as the Class Representative up to and including final approval of the Class Action
26 Settlement.

27 17. I signed a general release, so I am not only giving up my wage and hour claims, but I
28 am also giving up all claims beyond wage and hour claims I had against my former employer. Since I

have signed a general release for any and all claims related to my employment with Defendant, I cannot pursue any other claims against Defendant while Class Members can still pursue other claims not released in this Class Action.

18. This litigation has also resulted in a valuable benefit to the Class Members who will participate in the monetary payout of this Settlement because of my involvement. As a result of this Settlement, Class Members are receiving thousands of dollars in Settlement checks.

19. Likewise, I risk the potential stigma of being a Class Representative in a Class Action labor dispute, which may affect my future employment in this industry. A Google search with my name and Defendant show that I am a Plaintiff in this Class Action case.

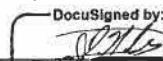
20. Based on the time, risk, stress, sacrifice of signing of a general release, and the great outcome of this case, I believe that the requested enhancement for me is fair and reasonable.
