1 **TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

2 **PLEASE TAKE NOTICE THAT** on **July 7, 2026 at 10:00 a.m.** in Department 6 of the
3 above-captioned Court located at Spring Street Courthouse, 312 North Spring Street, Los Angeles,
4 California 90012, pursuant to California Code of Civil Procedure section 382, Rule 3.769 of the
5 California Rules of Court, and California Labor Code section 2699(l), Sharon Baker (“Plaintiff”) will
6 and hereby does move the Court for an Order granting final approval of the proposed class action and
7 Labor Code Private Attorneys General Act of 2004, California Labor Code sections 2698, *et seq.*
8 (“PAGA”) settlement between Plaintiff and Defendant OPARC (“Defendant”).

9 Plaintiff requests that the Court enter an Order:

- 10 1. Granting final approval of the class action and PAGA settlement;
- 11 2. Approving the settlement as fair, adequate, and reasonable, based upon the terms as set
12 forth in the Court-approved Joint Stipulation of Class Action and PAGA Settlement (“Settlement
13 Agreement” or “Settlement”), including payment by Defendant of the Gross Settlement Amount of
14 Eight Hundred Fifty Thousand Dollars and Zero Cents (\$850,000.00) equal to the amounts to pay (1)
15 the Settlement Class Members and PAGA Employees pursuant to the terms of the Settlement; (2) the
16 Court-approved Attorneys’ Fees and Costs; (3) the Court-approved Enhancement Payment; (4) the
17 Court-approved Settlement Administration Costs; and (5) the Court-approved payment to the
18 California Labor and Workforce Development Agency (“LWDA”) pursuant to PAGA;
- 19 3. Approving Class Counsel’s request for one-third (1/3) of the Gross Settlement Amount,
20 i.e., Two Hundred Eighty-Three Thousand Three Hundred Thirty-Three Dollars and Thirty-Three
21 Cents (\$283,333.33) in attorneys’ fees, plus reimbursement of actual costs and expenses in the amount
22 of Nineteen Thousand Three Hundred Forty Dollars and Thirty-Seven Cents (\$19,340.37);
- 23 4. Approving the Enhancement Payment to Plaintiff in the amount of Ten Thousand
24 Dollars and Zero Cents (\$10,000.00) in recognition of her services to the Class Members;
- 25 5. Approving the Settlement Administration Costs to ILYM Group, Inc. in the amount of
26 Eight Thousand Nine Hundred Fifty Thousand Dollars and Zero Cents (\$8,950.00); and

8. Approving Thirty Thousand Dollars and Zero Cents (\$30,000.00) to be paid to the LWDA as seventy-five percent (75%) of the Forty Thousand Dollars and Zero Cents (\$40,000.00) allocated to civil penalties under PAGA.
