PROPOSED JUDGMENT

The Court, having reviewed the Joint Stipulation Requesting Approval of Private Attorney General Act Settlement (the "Stipulation") and the parties' fully signed Settlement Agreement attached as Exhibit "A" to the Stipulation, and good cause appearing therefore, the Court hereby orders entry of judgment in this action as follows:

1. The Court approves the parties' settlement of this action pursuant to Labor Code Section 2699(s)(2) as fair and reasonable in light of the facts and circumstances specific to this case;

2. Defendants Black Box Security, Inc. and Edan Yemini jointly and separately shall pay the gross settlement sum of \$325,000.00 ("Gross Settlement Sum") allocated as set forth in this Judgment;

3. From the Gross Settlement Sum, the Court awards Plaintiff's counsel Zack Broslavsky and Boris Dalis attorney's fees in the sum of \$ 87,500.00 ;

4. From the Gross Settlement Sum, the Court awards Plaintiff's counsel Zack Broslavsky and Boris Dalis costs in the sum of \$ 6,000.00 ;

5. From the Gross Settlement Sum, Defendants Black Box Security, Inc. and Edan Yemini jointly and separately shall pay Plaintiff the sum of \$ 75,000.00 in compromise and release of Plaintiff's individual claims (not the PAGA claim);

6. From the Gross Settlement Sum, Defendants Black Box Security, Inc. and Edan Yemini jointly and separately shall pay Phoenix Settlement Administrators the sum of \$ 4,000.00 to administer the settlement distribution;

7. From the Gross Settlement Sum, Defendants Black Box Security, Inc. and Edan Yemini jointly and separately shall pay \$ 152,500.00 in the following manner: \$ 99,125.00 [sixty-five percent (65%) of \$152,500.00] to the State of California Labor and Workforce Development Agency (the "LWDA Penalty Payment") and \$ 53,375.00 [thirty-five percent (35%) of \$152,500.00] to the PAGA Members (the "PAGA Representative Group Penalty Payment") as provided in the parties' Settlement Agreement, which is incorporated by this reference;

1 8. In compliance with Labor Code section 2699(s)(3), Plaintiff's counsel shall file a
2 copy of this Judgment with the Labor and Workforce Development Agency within 10 days of entry
3 of this Judgment;

4 9. Plaintiff's counsel shall give notice of entry of this Judgment;

5 10. Pursuant to Code of Civil Procedure section 664.6, this Court shall retain
6 jurisdiction with respect to all matters related to the administration and consummation of the
7 Settlement Agreement, and any and all claims asserted in, arising out of, or related to the subject
8 matter of the lawsuit, including but not limited to all matters related to the Settlement Agreement
9 and the determination of all controversies relating thereto; and

10 11. This action is hereby dismissed with prejudice.
