1 PLEASE TAKE NOTICE, on _____, at 9:00 a.m., or as soon as
2 the matter may be heard in Department 11B of the above-captioned court, located at 180 East
3 Weber Avenue, Stockton, California 95202, the Honorable Robert T. Waters presiding, Plaintiff
4 ANGEL CUELLAR (“Plaintiff”), on behalf of himself and others similarly situated and
5 aggrieved, will move this Court for an Order:

6 1. Preliminarily approving the Class and Representative Action Settlement as fair,
7 adequate, and reasonable based upon the terms set forth in the Settlement Agreement and
8 Release of Class and PAGA Claims (“Agreement”), including payment by New Bern Transport
9 Corporation, Pepsi-Cola Sales and Distribution, Inc., Pepsico, Inc. (“Defendants”) of the Gross
10 Settlement Amount of \$999,999.00;

11 2. Conditionally certifying the case as a class action for settlement purposes only;

12 3. Approving the Court Approved Notice of Class Action Settlement (“Class
13 Notice”) to be mailed to all Class Members advising them of the pendency of Class Action,
14 proposed Settlement, manner and procedure to submit requests for exclusion and objections to
15 the Settlement, automatic payment of their share of the Net Settlement Amount without the need
16 to return a claim form, date set for the Final Approval hearing, and of the right to appear at the
17 Hearing;

18 4. Appointing Isam C. Khoury, Michael D. Singer, and Maggie K. Realin of
