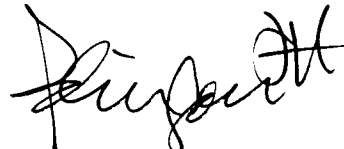
2 Having read and considered Plaintiff Tatyanna Jimenez's ("Plaintiff") Request for

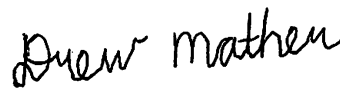
