1 **TO ALL PARTIES AND TO THEIR COUNSEL OF RECORD:**

2 Plaintiff EDGAR SORIANO (“Plaintiff”), individually and in his capacity as a representative  
3 of the State of California on behalf of other allegedly aggrieved employees and Defendant  
4 TRIPALINK, CORP. (collectively, “Defendant”) (Plaintiff and Defendant are collectively referred to  
5 herein as the “Parties”) have reached terms of settlement of this action alleging claims for relief  
6 pursuant to the Labor Code Private Attorneys General Act of 2004, Labor Code § 2698, *et seq.*  
7 (“PAGA”).

8 Plaintiff filed a Motion for an Order Approving Settlement of Claims Brought Pursuant to the  
9 Private Attorneys General Act of 2004 (“PAGA”) (the “Motion”) memorialized in the PAGA  
10 SETTLEMENT AGREEMENT (the “Settlement” or “Settlement Agreement”), a true and correct  
11 copy of which Settlement Agreement is attached as **Exhibit 1** to the Declaration of Lilit Tunyan  
12 submitted. The Court, having considered all the papers filed and otherwise being fully informed, and  
13 good cause appearing therefor, enters this Order and Judgment which is intended to be a final  
14 disposition of this Action in its entirety.

15 **IT IS HEREBY ORDERED and ADJUDGED** that the Motion for approval of settlement of  
16 claims brought pursuant to PAGA is **GRANTED** subject to the following findings and orders:

17 1. All terms used for purposes of this Order and Judgment, not otherwise defined, shall have  
18 the same meaning as given in the Settlement Agreement. The terms, provisions, and obligations set  
19 forth in the Settlement Agreement are deemed a part of this Order and Judgment incorporated herein  
20 in their entirety.

21 2. Pursuant to PAGA, California Labor Code § 2699(1)(2), the Labor and Workforce  
22 Development Agency (the “LWDA”) has been given timely notice of the Settlement Agreement. The  
23 Court finds and determines that Plaintiff’s notice of the Settlement to the LWDA complied with the  
24 statutory requirements of PAGA.

25 3. The Court has determined that the Settlement is, in all respects, fair, reasonable and  
26 accurate, and meets the requirements for approval under PAGA. Accordingly, the Court approves the  
27 Settlement.

1           4. The Court finds that the Gross PAGA Settlement Amount, Net PAGA Settlement Amount,  
2 and the methodology used to calculate and pay the LWDA PAGA Payment, and the Individual PAGA  
3 Payments to the Aggrieved Employees, in accordance with the Settlement, are fair and reasonable.

4           5. The Court confirms approval of the Settlement as to the following group of individuals,  
5 collectively referred to as the “Aggrieved Employees”:

6           All persons who are or were employed by Defendant in the State of California and  
7 classified as non-exempt from October 15, 2023 to December 5, 2025.

8           6. The Court approves the Notice to Aggrieved Employees, attached as Exhibit A to the  
9 Settlement Agreement.

10          7. Effective on the date when Defendant fully funds the entire Gross PAGA Settlement  
11 Amount and Plaintiff’s general release payment pursuant to the separate individual settlement  
12 agreement entered between Plaintiff and Defendant, the PAGA claims against the Released Parties are  
13 released as follows:

14           “All Aggrieved Employees are deemed to release, on behalf of themselves and their  
15 respective former and present representatives, agents, attorneys, heirs, administrators,  
16 successors, and assigns, the Released Parties from all claims for civil penalties under  
17 the California Private Attorneys General Act, California Labor Code § 2698, et. seq.  
18 (“PAGA”) based on the PAGA Period facts stated in the Operative Complaint and the  
PAGA Notice filed with the LWDA or that could have been alleged in the Operative  
Complaint and the PAGA Notice, based upon the facts and/or claims alleged in the  
Operative Complaint or in the PAGA Notice.”

19          The Released Parties are as follows:

20           “Defendant and each of its former and present directors, officers, shareholders, owners,  
21 members, attorneys, insurers, predecessors, successors, assigns, subsidiaries, and  
22 affiliates.”

23          8. The Court authorizes Phoenix Class Action Administration Solutions to act as the  
24 Settlement Administrator.

25          9. The Court authorizes the Settlement Administrator to calculate and pay the Settlement  
26 payments, in accordance with the terms of the Settlement.

27          10. Defendant is directed to deliver the Gross PAGA Settlement Amount to the Settlement  
28 Administrator within sixty (60) days after this Order is signed, as set forth in the Settlement

1 Agreement.

2 11. The Court approves the allocations and Gross PAGA Settlement Amount of **\$165,000.00**  
3 for the release of claims brought under PAGA, to be paid in accordance with the terms of the  
4 Settlement Agreement.

5 12. The Court awards the Settlement Administrator in this Action its fees and costs of  
6 **\$4,566.23** in accordance with the terms of the Settlement Agreement.

7 13. The Court awards to PAGA Counsel in this Action their fees of **\$55,000.00** in accordance  
8 with the terms of the Settlement Agreement. The Court awards to PAGA Counsel actual costs of  
9 **\$14,139.14** in accordance with the terms of the Settlement Agreement.

10 14. Under the terms of the Settlement Agreement, the Net PAGA Settlement Amount is  
11 **\$91,294.63**. Seventy-five percent (65%) of the Net PAGA Settlement Amount will be paid to the State  
12 of California Labor and Workforce Development Agency ("LWDA PAGA Payment"), and the  
13 remaining amount (35%) of the Net PAGA Settlement Amount shall be distributed to the Aggrieved  
14 Employees in accordance with the terms of the Settlement Agreement ("Individual PAGA Payment").

15 15. Each check for an Individual PAGA Payment sent to Aggrieved Employee shall be valid  
16 until the void date on the check. Funds remaining from any uncashed checks for Individual PAGA  
17 Payments will be disbursed to the California Controller's Office Unclaimed Property Fund in the name  
18 of the Aggrieved Employee.

19 16. Nothing in this Order and Judgment or the Settlement Agreement shall be construed as an  
20 admission or concession by any party. The Settlement and this resulting Order and Judgment simply  
21 represent a compromise of disputed allegations.

22 17. Plaintiff is directed to submit a copy of this Order and Judgment to the LWDA within ten  
23 (10) days of the date of this Order and Judgment.

24 18. After entry of this Order and Judgment, pursuant to California Rules of Court, Rule  
25 3.769(h) and Civil Procedure Code § 664.6, the Court shall retain jurisdiction to construe, interpret,  
26 implement, and enforce the Settlement Agreement and this Order and Judgment, to hear and resolve  
27 any contested challenge to a claim for settlement benefits, and to supervise and adjudicate any dispute  
28 arising from or in connection with the distribution of settlement proceeds.
