1 **TO ALL PARTIES AND THEIR ATTORNEYS OF RECORD:**

2 **PLEASE TAKE NOTICE** that on August 28, 2026, at 9:00 a.m., or as soon thereafter as
3 the matter may be heard, in Department 8A of the Sacramento County Superior Court, located at
4 500 G Street, Sacramento, CA 95814, before the Honorable Jill H. Talley, Plaintiff Sepideh
5 Mehrad Hosseini, individually and on behalf of all others similarly situated, will and hereby does
6 move the Court, pursuant to Code of Civil Procedure section 382, for entry of an Order granting
7 final approval of the parties' Class Action and PAGA Settlement Agreement (the "Settlement
8 Agreement" or "Settlement"). The Settlement was preliminarily approved by the Court on or
9 about April 10, 2026.

10 This Motion, which is supported and unopposed by Defendant Heartland Dental, LLC
11 ("Defendant"), seeks final approval of a \$392,265 Settlement on behalf of the Settlement Class
12 Members and entry of judgment.

13 Specifically, Plaintiff will and hereby does move the Court to grant final approval of the
14 Settlement Agreement and enter the Proposed Order and Final Judgment filed concurrently
15 herewith:

16 1. Finally certifying the Settlement Class, as defined in the Settlement Agreement
17 and the Court's Order Granting Preliminary Approval of the Class Action Settlement;

18 2. Finally appointing Plaintiff Sepideh Mehrad Hosseini as the Class Representative
19 for purposes of settlement;

20 3. Finally appointing Joshua Falakassa of Falakassa Law, P.C. and Mehrdad Bokhour
21 of Bokhour Law Group, P.C. as Class Counsel for purposes of settlement;

22 4. Finding that the Class Notice was properly provided to the Settlement Class in
23 accordance with the Court's Order Granting Preliminary Approval of Class Action Settlement;

24 5. Finally approving the Settlement as fair, adequate, and reasonable, based upon the
25 terms set forth in the Settlement Agreement;

26 6. Binding Participating Class Members to the terms of the Settlement Agreement,
27 including the Release specified therein; and

28 7. Retaining jurisdiction to enforce the Settlement Agreement.

8. Setting a Settlement Compliance Hearing on a Friday at 10:30 a.m. and directing Class Counsel, at least 15 days before the hearing, to file a declaration from the Settlement Administrator addressing the status of settlement administration and distribution, including the amounts distributed, the number and value of checks cashed and remaining uncashed, any amounts to the designated cy pres, and confirmation that all other payments required under the Settlement Agreement have been made

This Motion is based upon this notice, the accompanying memorandum of points and authorities, the Declarations of Mehrdad Bokhour and Joshua Falakassa in Support of Final Approval of Class Action Settlement, and the Declaration of Plaintiff Sepideh Mehrad Hosseini in Support of the Plaintiff's Motion for Preliminary Approval of Class Action Settlement, and the Declaration of Veronica Olivares of CPT Group, Inc.—all filed concurrently herewith; the records and files in this Action, and any other further evidence or argument that the Court may receive at or before the hearing.

Pursuant to Local Rule 1.06(A), the Court will issue a tentative ruling by 2:00 p.m. on the court day before the hearing. Tentative rulings may be accessed online via the Court's website. Parties without internet access may obtain the ruling by calling the department's dedicated telephone number, listed in the local telephone directory, between 2:00 p.m. and 4:00 p.m. on the court day before the hearing. If no party contacts the Court and opposing counsel by 4:00 p.m. the day before the hearing, the matter will be deemed submitted and no oral argument will be heard.

1 **MEMORANDUM OF POINTS AND AUTHORITIES**

2 **I. INTRODUCTION**

3 This motion seeks final approval of a wage-and-hour class action settlement between
4 Plaintiff Sepideh Mehrad Hosseini (“Plaintiff”) and Defendant Heartland Dental, LLC
5 (“Defendant”) (collectively, the “Parties”) in the amount of \$392,265 (the “Gross Settlement
6 Amount”) to be distributed to 113 individuals who are or were employed by Defendant as non-
7 exempt hourly employees in California from October 9, 2020 through April 10, 2026 (the “Class
8 Members” or the “Class”).

9 Plaintiff also represents a group of PAGA Members on behalf of the State of California
10 as private attorney general pursuant to the California Labor Code Private Attorneys General Act
11 of 2004 (“PAGA”). (Lab. Code, §§ 2698–2699.5.) The PAGA Members include any non-exempt
12 hourly employee who works or worked for Defendant in California at any time from October 9,
13 2023, through April 10, 2026.

14 A true and correct copy of the Class Action and PAGA Settlement Agreement
15 (“Settlement Agreement”) is attached as **Exhibit B** to the concurrently filed Declaration of
16 Mehrdad Bokhour in Support of Plaintiff’s Motion for Final Approval of Class Action Settlement
17 (“Bokhour Decl.”). The Settlement Agreement, in its entirety, is incorporated herein by reference.

18 On or about April 10, 2026, the Court granted preliminary approval of the Settlement
19 Agreement. Pursuant to that order, on May 19, 2026, CPT Group, Inc. (the “Settlement
20 Administrator” or “CPT”) mailed the Court-approved Notice of Proposed Class Action
21 Settlement (the “Class Notice”) to all Settlement Class Members. (See Declaration of Veronica
22 Olivares of CPT, in Support of Motion for Final Approval of Class Action Settlement (“Olivares
23 Decl.”), at ¶¶ 3-15.)

24 A copy of the Class Notice is attached to Olivares Decl. as **Exhibit A**.

25 **II. PERTINENT BACKGROUND AND SETTLEMENT TERMS**

26 Plaintiff and the Settlement Class Members include all current and former non-exempt,
27 hourly employees of Defendant who worked in California at any time between October 9, 2020,
28 and April 10, 2026. (Declaration of Mehrdad Bokhour in Support of Motion for Final Approval

of Class Action Settlement; ¶ 27 (“Bokhour Decl.”)).

Plaintiff’s primary allegations were that Defendant (1) failed to pay all wages owed, (2) failed to provide compliant meal and rest periods or pay compensation in lieu thereof at the “regular rate of pay”, (3) failed to provide accurate itemized wage statements, (4) failed to provide timely pay upon separation of employment, and (5) claims for civil penalties under the PAGA arising from the alleged Labor Code violations. (*Id.*)

The Settlement Class includes 113 individuals who performed work in a non-exempt position for Defendant in California at any time during the Class Period. The following is a breakdown reflecting how the funds are allocated under the Settlement Agreement (Declaration of Veronica Olivares Regarding Notice and Settlement Administration (“Olivares Decl.”), ¶ 13):

Settlement Class Members who did not opt-out of the Settlement in a timely manner will be deemed to have participated in the Settlement and shall become Participating Class Members without having to submit a claim form or take any other action. Each Participating Class Member will receive a pro-rata share of the Net Settlement Amount according to the percentage of weeks he/she worked during the Class Period, such that the amount actually distributed to Participating Class Members will equal 100% of the Net Settlement Amount.

Assuming the Court approves all of the amounts in the Settlement, the average payment to each Participating Class Member is estimated to be approximately **\$1,930.14**, and the highest payment is estimated to be approximately **\$6,606.42**. (Olivares Decl. ¶ 15.)

Thirty-three percent (33%) will be allocated as wages, subject to applicable local, state, and federal tax withholdings; and sixty-seven percent (67%) will be allocated as interest and as civil penalties (pursuant to, e.g., California Labor Code Sections 203 and 226) from which no

1 taxes will be withheld. Defendant must fully fund the Gross Settlement Amount, together with its
2 share of employer-side payroll taxes, no later than 15 days after the Effective Date. The
3 Administrator will disburse all Court-approved payments within 7 days after funding.

4 The Settlement allocates \$10,000 to resolve the PAGA claims, with 65% (\$6,500) payable
5 to the LWDA and 35% (\$3,500) distributed to the 60 PAGA Members as Individual PAGA
6 Payments pursuant to the allocation formula in the Settlement Agreement. (Lab. Code, § 2699,
7 subd. (m).) The Parties reached this allocation following extensive investigation, review of
8 payroll and timekeeping data, evaluation of potential exposure, and arm's-length negotiations
9 before an experienced mediator.

10 The Parties also considered the substantial litigation risks associated with the PAGA
11 claims, including disputes regarding whether any Labor Code violations occurred, whether
12 penalties could be established on a representative basis, whether penalties should be reduced
13 under Labor Code section 2699(e)(2), and whether Plaintiff could establish entitlement to recover
14 penalties for all alleged violations. Defendant denies all liability and contends that its policies and
15 practices complied with California law at all relevant times.

16 Additionally, the Settlement provides meaningful direct relief to the affected employees
17 while preserving its non-reversionary nature. Accordingly, the requested PAGA allocation is fair,
18 adequate, and reasonable under Labor Code section 2699(1)(2).

19 In light of this overwhelmingly positive reaction to the Settlement and its overall terms, it
20 is clear that the Settlement, which was the product of arm's-length negotiations, is fair and
21 reasonable, and the parties therefore respectfully request that the Court grant final approval and
22 enter the proposed judgment as requested. (See *Dunk v. Ford Motor Co.* (1996) 48 Cal.App.4th
23 1794, 1800–1802 [class action settlements should be approved if they are fair and reasonable, and
24 a low percentage of objectors and opt-outs is evidence of an agreement's fairness].)

25 **III. THE NOTICE PROCESS**

26 **A. Notice to the Settlement Class Members**

27 Pursuant to the Court's Preliminary Approval Order and the Settlement Agreement, the
28 parties directed the Settlement Administrator to review and update the Settlement Class

Members' addresses, mail the Court-approved Class Notice to the Settlement Class Members, and process their responses. (Olivares Decl. ¶¶ 3-5.) Before mailing the Class Notice, the Settlement Administrator performed a National Change of Address search on all Settlement Class Members to determine if any had moved. (Olivares Decl. ¶ 5.)

Of the 113 Class Notices mailed, 2 were returned without forwarding addresses. CPT conducted skip traces and remailed both Notices to updated addresses. As of the date of CPT's declaration, none of the remailed Notices had been returned as undeliverable. CPT received no disputes, objections, or requests for exclusion. Accordingly, all 113 Class Members are Participating Class Members, resulting in a 100% participation rate. (Olivares Decl., ¶¶ 7-13.)

In accordance with California Rules of Court, rules 3.766 (d) and 3.769 (f), the Class Notice provided Settlement Class Members with (1) a brief explanation of the case; (2) an explanation of each Settlement Class Member's right to opt out of the Settlement Class; (3) an explanation of the process (and relevant deadlines) through which a Settlement Class Member could opt out of the Settlement Class; (4) notice about the binding nature of the Judgment for Settlement Class Members who do not opt-out; (5) an explanation of each Settlement Class Member's right to appear through counsel; (6) an explanation of each Settlement Class Member's right to appear at the fairness hearing and express views on the Settlement, i.e., object or otherwise respond; and (7) an explanation of each Settlement Class Member's right to participate in the Settlement and receive payment accordingly. (Attached hereto as **Exhibit "A"** to the Veronica Olivares Declaration is a true and correct copy of the Class Notice.)

B. There are Zero Objections and Zero Requests for Exclusion

California law makes clear that the percentage of objectors and opt-outs is an important factor in the Court's consideration of a proposed class action settlement. (See *Dunk, supra*, 48 Cal.App.4th at 1802.) Indeed, the Ninth Circuit and other federal courts recognize that in the final fairness analysis, the number or percentage of class members who object to the settlement is a significant factor. (See *Mandujano v. Basic Vegetable Prods., Inc.* (9th Cir. 1976) 541 F.2d 672, 677; *In re American Bank Note Holographics, Inc.* (SDNY 2001) 127 F.Supp.2d 418, 425 ["[i]t is well settled that the reaction of the class to the settlement is perhaps the most significant factor

1 to be weighed in considering its adequacy.”)

2 Because CPT received no requests for exclusion, all 113 Class Members are Participating
3 Class Members. Thus, the Settlement Class overwhelmingly viewed this as a fair and reasonable
4 Settlement.

5 **IV. EVALUATION OF THE SETTLEMENT**

6 **A. The Settlement Was Reached Through Informed Arms-Length Negotiation**

7 Courts presume the absence of fraud or collusion in the negotiation of a settlement unless
8 evidence to the contrary is offered. Thus, there is a presumption here that the negotiations were
9 conducted in good faith. (*See* 3 Alba Conte & Newberg, *supra*, at § 11.51.) The proposed
10 Settlement here was the product of arm’s-length negotiations before a highly experienced and
11 reputable California wage-and-hour class-action mediator, Kelly Knight, Esq.

12 Here, Plaintiff and Class Counsel have diligently investigated the claims raised in this
13 litigation and, after taking into account the disputed factual and legal issues involved in this
14 action, the risks attending further prosecution, and the benefits to be received pursuant to the
15 compromise and settlement of the Action as set forth in the Settlement, concluded that the
16 Settlement terms are fair, reasonable, and in the best interest of the Settlement Class.

17 As the Settlement Agreement itself reveals, there is no preferential treatment for any
18 segment of the Settlement Class, as the Settlement is designed to fairly and adequately
19 compensate all Settlement Class Members. Pursuant to California Rules of Court Rule 3.769(b),
20 the parties have disclosed the agreed-upon and proposed attorneys’ fees, which are well within
21 the range of reasonableness for matters of this nature.

22 **B. Plaintiff’s Investigation Was More Than Sufficient**

23 As set forth at the time of preliminary approval, Class Counsel’s extensive investigation
24 into the facts and merits of the wage and hour claims alleged included analyzing substantial
25 amounts of information, correspondence, documents, timekeeping records, and payroll data,
26 relevant wage and hour policies and procedures, and evidence relating to the class size and the
27 commonality of the claims.

28 During this process, Plaintiff and Class Counsel conducted investigations into the

1 potential claims of similarly situated employees, including interviewing multiple putative class
2 members, and researching Defendant’s defenses.

3 Finally, Class Counsel synthesized and analyzed information provided by Defendant
4 regarding the total Settlement Class Members, the number of current and former non-exempt
5 employees, and the number of employees who worked during various time periods and prepared
6 comprehensive damages calculations regarding the wage and hour claims at issue.

7 **C. Class Counsel Are Experienced in Similar Litigation and Endorse the**
8 **Settlement**

9 Class Counsel are experienced in this type of litigation, and they have (and hereby do)
10 represent that this Settlement is fair and reasonable. (Bokhour Decl., ¶¶ 3-13; Declaration of
11 Joshua Falakassa in Support of Plaintiff’s Motion for Final Approval of Class Action Settlement
12 (“Falakassa Decl.” ¶¶ 3-8); *see 7-Eleven Owners for Fair Franchising v. Southland Corp.* (2000)
13 85 Cal.App.4th 1135, 1152 [Final approval of settlement affirmed where counsel were all
14 experienced litigators with class-action experience and had recommended settlement based on the
15 negotiated terms].)

16 **D. Reasonable Estimate of the Nature and Amount of Recovery**

17 Plaintiff’s Motion for Preliminary Approval contained a comprehensive *Kullar* analysis
18 (which sufficiently provided the Court with “basic information about the nature and magnitude
19 of the claims in question and the basis for concluding that the consideration being paid for the
20 release of those claims represents a reasonable compromise” (*Kullar v. Foot Locker Retail, Inc.*
21 (2008) 168 Cal.App.4th 116, 133.)

22 In light of the uncertainties of protracted litigation, this negotiated Settlement reflects the
23 best practicable recovery for the Settlement Class. While the total Settlement amount is, of course,
24 a compromise figure, the potential risks and opportunities for both parties were carefully weighed,
25 resulting in a fair and equitable Settlement. Based upon detailed data obtained through discovery
26 and information exchanges and factoring in claim certification probabilities and liability
27 probabilities, Class Counsel formulated detailed damages models to evaluate the claims in
28 preparation for mediation and to reach a realistic and reasonable resolution.

1 Of course, Defendant denies that any damages should be assessed and denies all of the
2 value assessed by Plaintiff. (*Id.*) Notwithstanding these arguments, the Settlement commits
3 Defendant to pay a Settlement Amount of \$392,265 to settle the litigation.

4 **V. THE REQUESTED ATTORNEYS' FEES ARE FAIR, REASONABLE, AND**
5 **SHOULD BE AWARDED**

6 For their efforts in creating a common fund for the benefit of the Settlement Class, the
7 Settlement Agreement provides that Class Counsel may seek reasonable attorneys' fees of
8 \$130,755, which is one-third of the Settlement Amount. These fees are warranted under the law
9 and within the range of fees commonly awarded in similar class action cases.

10 As shown herein, the requested percentage of one-third of the Settlement Amount as
11 payment for Attorneys' Fees should be granted for several reasons, including the following: (1)
12 one-third is the standard benchmark in California for class action settlements (see *e.g.*, *Chavez v.*
13 *Netflix, Inc.* (2008) 162 Cal.App.4th 43, 66 n. 11 ("Empirical studies show that, regardless
14 whether the percentage method or the lodestar method is used fee awards in class actions average
15 around one-third of the recovery"); and (2) that the California Supreme Court recently held that
16 the percentage of the fund method survives in California class action cases (*Laffitte v. Robert Half*
17 *International, Inc.* (2016) 1 Cal.5th 480).

18 Accordingly, Plaintiff's Attorneys' Fees request should receive final approval.

19 **A. Plaintiff is Entitled to Recover Reasonable Attorneys' Fees Under the Labor**
20 **Code**

21 Plaintiff and the Settlement Class in this action are entitled to recover reasonable
22 Attorneys' Fees and Costs under section 218.5 of the California Labor Code, which provides that,
23 "[i]n any action brought for the nonpayment of wages ... the Court shall award reasonable
24 attorneys' fees and costs to the prevailing party."

25 In addition, Plaintiff and the Settlement Class are entitled to recover reasonable Attorneys'
26 Fees pursuant to Labor Code section 1194, subdivision (a), which provides that, "... any
27 employee receiving less than the legal minimum wage ... applicable to the employee is entitled
28 to recover in a civil action the unpaid balance of the full amount of this minimum wage...

1 including ... reasonable attorney's fees, and costs of suit."

2 Plaintiff is further entitled to Attorneys' Fees and Costs under section 226(e) of the Labor
3 Code (employee who prevails on claim for itemized wage statement violation "is entitled to an
4 award of costs and reasonable attorneys' fees"); under PAGA (Labor Code § 2699(k)(1), which
5 provides "Any employee who prevails in any action shall be entitled to an award of reasonable
6 attorney's fees and costs, including any filing fee paid"); and, potentially, section 1021.5 of the
7 California Code of Civil Procedure.

8 **B. Class Counsel's Request for Fees Is Reasonable and Properly Calculated as**
9 **a Percentage of the Common Fund**

10 Under the "common fund" doctrine, the request for Attorneys' Fees in the amount of 1/3
11 of the Settlement Amount is reasonable and appropriate, because (1) it is within the approved
12 range for percentages awarded as attorneys' fees in similar cases; (2) it is supported by the high
13 quality and amount of Class Counsels' work on this case and the positive results obtained for the
14 Settlement Class; (3) the Settlement Class had sufficient notice of the attorneys' fee request; and
15 (4) it is supported by the fact that this case was handled on a contingency basis and was undertaken
16 despite numerous risks and expenses.

17 ***1. The Attorneys' Fees Requested Here Fall Within the Reasonable Range***
18 ***Awarded in Similar Cases Under the Well-established Common Fund***
19 ***Method***

20 The California Supreme Court has approved trial courts' use of the common fund method
21 for awarding attorneys' fees in wage-and-hour class actions, like this one, and routinely upholds
22 attorneys' fee requests of 1/3 of the total settlement amount obtained for the class. (*See Laffitte v.*
23 *Robert Half Int'l Inc.* (2016) 1 Cal. 5th 480, 506; *see also*, 4 Newberg on Class Actions, § 14:6 at
24 552 ("fee awards in class actions average around one-third of the recovery").

25 ***2. The High Quality of Work and Excellent Results Obtained Support the***
26 ***Award***

27 In addition to the fact that a class benefit was created with a significant common fund, the
28 fairness of the requested fee award of one-third of that common fund is supported by the high

1 quality of work performed by Class Counsel and the favorable result obtained for the Class
2 Members given the significant challenges faced by Plaintiff in this action. As the record
3 demonstrates, Class Counsel conducted the litigation on behalf of the class in a competent,
4 professional, and efficient manner. In doing so, Class Counsel confronted substantial litigation
5 risks with well-developed arguments, careful factual analysis, and a creative strategy to overcome
6 legal obstacles, including challenging factual issues pertaining to each substantive claim. The
7 effective legal work performed by Class Counsel, which resulted in a significant benefit for class
8 members, justifies the one-third of the common fund that is requested as reasonable attorneys'
9 fees.

10 Class Counsel diligently, efficiently, and creatively pursued this case and promptly
11 reached a successful settlement for the benefit of the Class Members. Despite the numerous risks
12 and obstacles afflicting Plaintiff's claims as detailed in Plaintiff's Motion for Preliminary
13 Approval, Plaintiff's counsel crafted and negotiated a fair and reasonable Settlement Agreement
14 for the benefit of the Class Members.

15 The fact that the settlement was embraced and supported by the Class Members, as
16 evidenced by zero objections and zero opt-outs out of 113 Class Members, clearly demonstrates
17 that the Class Members support the Settlement Agreement and results achieved by Class Counsel
18 through the litigation of this matter.

19 Moreover, Class Counsel demonstrated professional skill that benefited the Settlement
20 Class. Class Counsel developed the legal arguments, evaluated the factual issues, and
21 implemented an effective litigation and negotiation strategy, ultimately obtaining a Settlement
22 that provides significant monetary relief to the Settlement Class.

23 As a result of this litigation, the Class Members stand to receive a significant Net
24 Settlement Amount of \$218,106.25.

25 **3. Settlement Class Members Had Sufficient Notice of the Requested Fees**

26 Rule 3.769 of the California Rules of Court requires that the Class Members be notified
27 of any agreement regarding an application for attorneys' fees. Here, the Class Notice,
28 preliminarily approved by the Court and distributed to the Settlement Class Members, apprised

1 them that Class Counsel will ask for Attorneys' Fees of one-third of the Settlement Amount as
2 reasonable compensation for the work Class Counsel performed and will continue to perform in
3 this lawsuit through final approval. (Olivares Decl., ¶ 3 & Ex. A.)

4 The Class Notice also advised the Settlement Class Members of the procedures for
5 objecting to the proposed Settlement and appearing at the settlement hearing, where they could
6 present their objections to any aspect of the Settlement, including the amount of Attorneys' Fees
7 to be awarded to Class Counsel. (*Litwin v. iRenew Bio Energy Solutions, LLC* (2014) 226
8 Cal.App.4th 877, 883 [“[p]rocedural due process requires that affected parties be provided with
9 ‘the right to be heard at a meaningful time and in a meaningful manner’”].)

10 In accordance with the foregoing, it is respectfully submitted that the instant notice
11 complied with Rule 3.769 and, as a result, the Settlement Class Members' due process rights were
12 fulfilled.

13 **4. The Contingent Nature of Class Counsel's Representation of Plaintiff**
14 **and the Settlement Class Further Supports the Fee Award at 1/3 of the**
15 **Common Fund**

16 An additional factor in favor of granting the requested fee award is that this case was both
17 legally and financially risky for Class Counsel. (*See Vizcaino v. Microsoft Corp* (9th Cir. 2002)
18 290 F.3d 1043, 1048-49.) Class Counsel has been representing the Settlement Class in this matter
19 on a strictly contingency basis and, as such, incurred the risk of non-recovery after a substantial
20 investment of time, money, and resources and has done so since the inception of this case without
21 any payment or compensation. Specifically, there was the prospect of enormous cost inherent in
22 this class action litigation, as well as the prospect of a prolonged battle with well-funded
23 corporations who were represented by an experienced law firm; the risk that Defendant could
24 prevail on their arguments that the Settlement Class should not be certified; and the risk that
25 Defendant could prevail on the merits of some or all of the claims.

26 If Plaintiff had lost this case, Class Counsel would have recovered nothing and would
27 have lost its out-of-pocket costs.

28 Finally, the absence of any valid objections to the requested fee award, coupled with the

1 100% Class participation rate, also supports the appropriateness and reasonableness of the
2 requested attorneys' fees. (*In re Heritage Bond Litigation* (C.D. Cal., June 10, 2005, No. 02-ML-
3 1475 DT) 2005 WL 1594403, at *21 ["The absence of objections or disapproval by class members
4 to Class Counsel's fee further supports finding the fee request reasonable."].)

5 **5. A Lodestar Cross-Check Confirms the Reasonableness of the Fee Award**

6 Despite recognized limitations of the so-called lodestar method, some California and
7 federal courts acknowledge the utility of a lodestar "cross-check."¹ (*Lealao, supra*, 82 Cal.App.
8 4th at 46-47.) Under the "lodestar multiplier" method of cross-checking the reasonableness of
9 attorneys' fees in class actions, the court ascertains Class counsel's total "lodestar" amount by
10 multiplying the number of hours reasonably expended by each attorney or legal staff member by
11 their hourly rates, and then enhances or reduces this lodestar figure by a "multiplier" to account
12 for a range of factors, such as the novelty or difficulty of the case, its contingent nature, and the
13 degree of success achieved. *PLCM Group, Inc. v. Drexler* (2000) 22 Cal.4th 1084, 2655-96; *Press*
14 *v. Lucky Stores, Inc.* (1983) 34 Cal.3d 311, 322; *Lealao, supra*, 82 Cal.App.4th at 43 [court has
15 discretion to use a multiplier to ensure that the "fee awarded is within the range of fees freely
16 negotiated in the legal marketplace in comparable litigation"].)

17 Historically, California courts have approved multipliers of 1.5 to 4. *See Coalition for*
18 *Los Angeles County Planning v. Board of Supervisors* (1977) 76 Cal.App.3d 241, 251 (multiplier
19 of 2+ approved); *Sternwest Corp v. Ash* (1986) 183 Cal.App.3d 74, 75. The multiplier requested
20 by Class Counsel below is within the range of multipliers found to be appropriate by various
21 federal and state courts in California. In *Sternwest Corp. v. Ash* (1986) 183 Cal.App.3d 74, for
22 instance, the Court of Appeal remanded for a lodestar enhancement of "two, three, four or
23 otherwise." *Id.* At 76; *see also Wershba*, 91 Cal.App.4th at 255 ("Multipliers can range from 2 to
24 4 or even higher"); *City of Oakland v. Oakland Raiders* (1988) 203 Cal.App.3d 78, 83 (affirming
25 2.34 multiplier); *Coalition for Los Angeles County Planning in the Pub. Interest v. Board of*
26

27 ¹ In practice, the lodestar method is difficult to apply, time-consuming to administer, inconsistent in result, and
28 capable of manipulation. In addition, the lodestar creates inherent incentive to prolong the litigation until sufficient
hours have been expended. Herr, David F., *Manual for Complex Litigation*, § 14.121 (1988); *See also In re Activision*
(N.D. Cal 1989) 723 F.Supp 1373.

Supervisors, 76 Cal.App.3d 241, 251 (affirming multiplier of approximately 2); *See also Steinder v. Am. Broadcasting Co., Inc.* (9th Cir. 2007) 248 Fed. Appx. 780, 783 (approving a multiplier of 6.85 and citing cases with comparable or higher multipliers); *Vizcaino v. Microsoft Corp.* (9th Cir. 2002) 290 F.3d 1043, 1051 (finding no abuse of discretion in awarding a multiplier of 3.65).

In *Torchia v. WW Grainger, Inc.* (E.D. Cal. 2014) 304 F.R.D. 256, 275-278, a federal magistrate in Fresno approved attorneys' fees of \$550,000 constituting a 3.57 multiplier on class counsel's total lodestar of \$153,856, in a wage and hour class action where class counsel expended 457.85 hours on the case, engaged in limited formal discovery, and where the case settled for \$2,750,000 within one year from filing the Complaint with 909 class members claiming \$1,305,200 and the remainder, except for the attorneys' fees and costs, reverting to the company.

As set forth in the declarations of Class Counsel submitted herewith, the actual aggregated lodestar between the attorneys working on this case is approximately \$101,187.50, which is summarized in the following table and the declaration of Class Counsel:

(See Bokhour Decl., ¶ 19-20, Falakassa Decl. ¶ 16.)

The requested fee of \$130,755 represents a 1.28 multiplier on Class Counsel's lodestar, well within the range of multipliers commonly approved by California and Ninth Circuit courts to account for contingency risk and the results achieved.

The hourly rates above are comparable to those of other attorneys with equal or similar experience, if not somewhat lower. Thus, not only are Plaintiff's Counsel's rates reasonable and typical, but the attorneys' fees requested are in line with Plaintiff's Counsel's lodestar, all

² Includes an estimated 10 hours of additional work preparing for and attending the hearing (inclusive of finalizing and filing the motion, appearing at the hearing, addressing the Court's questions/concerns, submitting revised documents, responding to class members who are anxious to receive their check, and so on), as well as 10 hours in anticipated work to be performed after the final approval, working with counsel, administrator, and Class Members (which includes up to 1.5 years of case management relating to ensuring timely payment from Defendant, reviewing the calculations, checks are timely mailed, responding to class members questions about the timing of checks/missing checks/lost checks and remailings, working with the administrator regarding uncashed checks and remailings, assisting with the Administrator's declarations regarding payments and uncashed checks, potentially filing an amended judgment, appearing at the final disbursement hearing and/or submitting paperwork related thereto.

1 confirming that the fee request is fair and reasonable.

2 Class Counsel are also highly experienced in Class/PAGA litigation, including being
3 selected as a “Super Lawyer” in employment litigation on multiple occasions and achieving some
4 of the largest settlements in California from 2021 through 2025. (Bokhour Decl. ¶¶ 2-6; Falakassa
5 Decl. ¶¶ 3-8). Indeed, Class Counsel’s rates are typical of those charged by defense counsel with
6 similar experience doing similar employment litigation in this region.

7 **VI. THE REQUESTED COSTS AND SERVICE PAYMENT ARE REASONABLE**

8 **A. The Requested Costs Are Reasonable and Merit Approval**

9 Class Counsel’s actual costs through the final approval hearing are estimated at
10 \$18,403.75. (Bokhour Decl. ¶ 24.) These costs encompass mediation, filing, expert, and process
11 service fees. They are reasonable and uncontested.

12 **B. The Requested Class Representative Service Payment is Reasonable and**
13 **Merits Approval**

14 A named plaintiff is an essential ingredient of any class action, and a service payment
15 is appropriate to induce individuals to step forward and assume the burdens and obligations of
16 representing the settlement class. Courts regularly approve service payments to compensate
17 named plaintiffs for their service to the class and the risks they incurred during the litigation.
18 (*See, e.g., Bell v. Farmers Insurance Exchange* (2004) 115 Cal.App.4th 715, 726 (upholding
19 “service payments” to named Plaintiff for their efforts in bringing class action); *Rodriguez v.*
20 *West Publishing* (9th Cir. 2009) 563 F.3d 948, 959 (stating that incentive awards are “intended
21 to compensate class representatives for work done on behalf of the class, to make up for
22 financial or reputational risk undertaken in bringing the action, and, sometimes, to recognize
23 their willingness to act as a private attorney general.”).

24 Under the Settlement, Defendant agreed not to oppose Plaintiff’s request for a Class
25 Representative Service Payment in the amount of \$10,000, which Plaintiff seeks in recognition
26 of her contributions as the Class Representative. Plaintiff came forward and undertook
27 significant risk, including the risk of being blackballed in the industry and the risk that she could
28 have been liable for Defendant’s costs if he lost the case. This factor is significant for a relatively

low-wage earner, and the potential risk is very real. (*See Whiteway v. FedEx Kinkos Office & Print Svcs., Inc.* (N.D. Cal. Dec. 17, 2007) No. C 05-2320 SBA, 2007 WL 4531783, at *3 (“the few courts to consider this ‘class representatives’ dilemma’ have not found it inequitable to assess costs upon the lead or named plaintiff in a class action.”).)

As further detailed in Plaintiff’s Declaration in Support of Preliminary Approval of Class Action Settlement on file with this Court, Plaintiff committed a significant number of hours to assist with the investigation, litigation, and settlement processes of this case to assist on the matter. Plaintiff also spent considerable time helping to prepare for and assist with the mediation and settlement process. The requested Class Representative Service Payment of \$10,000 to Plaintiff is reasonable, particularly in light of the substantial benefits Plaintiff generated for the Settlement Class Members, the risks she undertook, and in exchange for executing a general release against Defendant while giving up the right to separately pursue his individual wage and hour claims.

The Class Notice sent to each Settlement Class Member detailed the proposed Class Representative Service Payment. No Settlement Class Member objected to the proposed payment to Plaintiff. Thus, Plaintiff requests that the Court approve the service payments as both reasonable and appropriate.

VII. OTHER MATTERS RE: FINAL APPROVAL

A. Settlement Administration Costs

The parties agreed that the Settlement Administrator, CPT, would be compensated for services performed. The Settlement Administrator’s requested fee is \$5,000.

B. Uncashed Checks

The Settlement Agreement provides that any uncashed checks will be transmitted to the California Dental Association Foundation as the Court-approved *cy pres* recipient.

C. Final Report

Defendant must fully fund the Gross Settlement Amount, together with its share of employer-side payroll taxes, no later than 15 days after the Effective Date. The Administrator will disburse all Court-approved payments within 7 days after funding. Settlement Class

Members will have 180 days to cash their checks. As such, the parties propose submitting a final report in the form of a declaration from the Settlement Administrator (setting forth the amount paid to the California Dental Association Foundation as cy pres, within 30 days of the check-cashing deadline).

D. Submission to the LWDA

As set forth in ¶ 25 of the Declaration of Mehrdad Bokhour in Support of Final Approval of Class Action Settlement, the Settlement was previously submitted to the LWDA in accordance with Labor Code § 2699(s)(2).

VIII. CONCLUSION

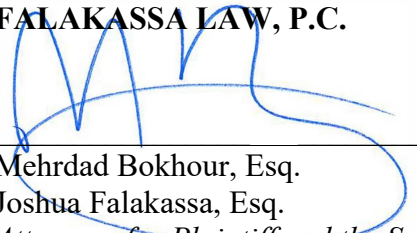
