1 Plaintiff ARNULFO MARQUEZ, on behalf of all others similarly situated and the State of
2 California under the Private Attorneys General Act (“Plaintiff”) brings this FIRST AMENDED
3 CLASS AND REPRESENTATIVE ACTION COMPLAINT against Defendants CORELATION,
4 INC. and DOES 1 through 50, inclusive (collectively “Defendants”), alleging as follows:

5 **INTRODUCTION**

6 1. Plaintiff brings the instant class action on behalf of themselves and similarly situated
7 current and former employees of Defendants for a series of systemic violations of the California Labor
8 Code and IWC Wage Orders.

9 2. Defendants underpaid overtime, paid sick leave, vacation wages, and premiums by
10 failing to include non-discretionary bonuses, differentials, and all other forms of non-excludable
11 remuneration into the regular rate of pay calculations.

12 3. Defendants failed to pay Plaintiff and other employees for all regular and overtime
13 hours due to their policy and practice of editing time records and/or removing hours worked (i.e. time
14 shaving).

15 4. Defendants failed to provide, authorize, and/or permit the class members to take all
16 meal and rest periods to which they were entitled. Yet, Defendants did not pay Plaintiff and the class
17 members for all meal or rest period premiums.

18 5. Defendant failed to reimburse Plaintiff and class members for necessary expenses
19 incurred in furtherance of the class members’ job duties.

20 6. Defendant’s employment policies and practices, as well as their payroll administration
21 systems, enabled and facilitated these violations on a company-wide basis with respect to class
22 members.

23 7. Defendant is further liable for derivative claims for wage statements, untimely
24 payment, and other associated violations.

25 8. Plaintiff seeks to recover the damages, wages, interest, and penalties, in addition to
26 attorneys’ fees and costs, according to proof.

1 **JURISDICTION & VENUE**

2 9. Jurisdiction of this action is proper in this Court under Article VI, Section 10 of the
3 California Constitution as the causes of action are premised upon violations of California law.

4 10. The monetary damages and restitution sought exceed the minimal jurisdiction limits of
5 the Superior Court.

6 11. This Court has jurisdiction over Defendants because, upon information and belief,
7 Defendants have sufficient minimum contacts in California, or otherwise intentionally avail
8 themselves to the California economy so as to render the exercise of jurisdiction over them by the
9 California courts consistent with traditional notions of fair play and substantial justice.

10 12. Venue is proper in this Court under Code of Civil Procedure sections 393(a), 395,
11 and/or 395.5 because, upon information and belief, Defendants conducted business and committed
12 some of the alleged violations in this County.

13 **PARTIES**

14 **A. Plaintiff Arnulfo Marquez**

15 13. Plaintiff Marquez is an individual over 18 years of age who worked for Defendants in
16 California as a non-exempt employee from about April 2021, to December 2024. Plaintiff worked as
17 an Integration Analyst.

18 14. The State of California, via the Labor and Workforce Development Agency
19 (“LWDA”), is the real party in interest in this action. (*Kim v. Reins Int’l California, Inc.* (2020) 9
20 Cal. 5th 73, 81 [The “government entity on whose behalf the plaintiff files suit is always the real party
21 in interest.”])

22 **B. Defendants**

23 15. Defendant Corelation, Inc. is a California corporation that maintains operations and
24 conducts business throughout the State of California, including in this county.

25 16. The true names and capacities, whether individual, corporate, or otherwise, of the
26 parties sued as DOES 1 through 50, are presently unknown, unascertainable, or uncertain, and are sued
27 by such fictitious names under Code of Civil Procedure section 474. Upon information and belief,
28 each of DOES 1 through 50 constitutes a legal employer or is otherwise legally responsible in some

manner for the acts and omissions alleged herein. This Complaint may be amended to reflect their true names and capacities once ascertained.

17. Upon information and belief, Defendants in this action are employers, co-employers, joint employers, and/or part of an integrated employer enterprise, as each of the Defendants exercised control over the wages, hours, and working conditions of the employees, suffered and permitted them to work, and otherwise engaged them as employees under California law.

18. Upon information and belief, at least some of the Defendants have common ownership, common management, interrelationship of operations, and centralized control over labor relations and are therefore part of an integrated enterprise and thus jointly and severally responsible for the acts and omissions alleged herein, including pursuant to Labor Code sections 558, 558.1, and 1197.1.

19. Upon information and belief, Defendants acted in all respects pertinent to this action as an alter-ego, agent, servant, joint employer, joint venturer, co-conspirator, partner, in an integrated enterprise, or in some other capacity on behalf of all other co-defendants, such that the acts and omissions of each defendant may be legally attributable to all others.

CLASS ALLEGATIONS

20. This action is brought individually and on behalf of the following class pursuant to Code of Civil Procedure section 382:

- a. All current and former non-exempt employees who worked for Defendants in California at any time from four years (plus the additional 178-day statutory tolling period under Emergency Rule 9) prior to the filing of this action through date of class certification.

21. Plaintiff reserves the right to establish various subclass definitions as appropriate at the class certification stage, according to proof.

22. The class is ascertainable and shares a well-defined community of interest in this litigation:

- a. Numerosity: The class is estimated to exceed 50 individuals, although the precise membership of the entire class is unknown at this time. The class is so numerous that joinder of all class members is impracticable. The identities of

class members are ascertainable by inspection of Defendants' employment and payroll records.

b. Typicality: Plaintiff's claims are typical of the claims of the other class members. They were subject to the same policies and practices of Defendants, which resulted in losses to the class. Proof of common unlawful business practices, which Plaintiff experienced, will establish the right of the class to recover on the causes of action alleged herein.

c. Adequacy: Plaintiff is an adequate class representative; will take all necessary steps to protect the class members' interests adequately and fairly; has no interest antagonistic to other class members; and is represented by attorneys who have substantial experience prosecuting, defending, resolving, and litigating wage and hour class, collective, and representative actions in California state and federal courts.

d. Superiority: A class action is superior to other means for adjudicating this dispute. Individual joinder is impractical. Class treatment will allow for common issues to be resolved in a single forum, simultaneously, and without duplication of effort and expense.

e. Public Policy Considerations: Certification of this lawsuit as a class action advances the State of California's strong public interest in ensuring its approximately millions of employed residents are properly paid the wages they earned for the hours they worked. Class actions provide a mechanism for enforcement of labor laws and allow for vindication of employee rights by unnamed class members.

23. Common questions of law and fact as to the class members predominate over questions affecting only individual members. The common questions of law and fact exist as to whether the employment policies and practices formulated by Defendants and applied to the class members constitute violations of California law.

GENERAL ALLEGATIONS

24. Plaintiff and class members worked for Defendant as non-exempt employees and were compensated on an hourly basis.

25. Defendants failed to pay Plaintiff and the class members at the lawful minimum wage rate for all hours worked, resulting in unpaid minimum wages.

26. Plaintiff alleges that Defendants maintained an unlawful policy and practice of editing Plaintiff's and, on information and belief, other class members time records to show fewer hours worked on their timecards and avoid paying all overtime pay and meal period premiums. Specifically, Defendants' required Plaintiff to modify his lunchtime on his timesheet from 30 minutes to one hour, when he was only able to take one 30-minute meal period. Plaintiff manually inserts his clock in time on the time sheet, but those punch times must be approved by management before they are submitted. However, his supervisors forced him to change his original lunch time from 30 minutes to one hour, or else his timesheet would not get approved.

27. An illustrative example of this violation is shown on Plaintiff's time records from 11/02/2024 to 11/05/2024. Here, Plaintiff's time records indicate that he took a meal period for exactly one hour from 11/02/2024 to 11/05/2024. However, Plaintiff alleges that in order for these time records to get approved, his supervisors forced him to change his original lunch time from 30 minutes to one hour, or else his timesheet would not get approved. In fact, on 11/07/2024, Plaintiff received an email from his supervisor directing him to change his timecard to reflect that he took an hour lunch, when he did not.

28. Due to this time-shaving practice, all hours worked were not directly compensated, resulting in minimum wage violations. Defendants' pattern of editing employee's time records resulted in an underpayment of regular and overtime wages to Plaintiff and the class members. These revisions were made without employees' consent. Plaintiff and the class members were deprived of regular and overtime wages each time Defendant altered their clock-out time and overall records.

29. Defendants failed to pay Plaintiff and the class members overtime wages and the lawful rate of pay for overtime hours worked, resulting in unpaid overtime wages.

1 30. First, as a result of Defendants editing Plaintiff's and class members time records to
2 include false meal periods, Defendants failed to compensate Plaintiff and the class members for all
3 overtime hours worked. Each time this practice resulted in unpaid work over 8 hours in a day or 40
4 hours in a week, this resulted in unpaid overtime.

5 31. Second, Defendants failed to pay overtime at the regular rate of pay. Plaintiff and the
6 class members earned overtime in the same pay period they earned bonuses or other non-excludable
7 remuneration, which Defendants did not include in the regular rate of pay.

8 32. An illustrative example of this violation is shown on Plaintiff's Wage statement for the
9 pay period from 11/27/2024 to 12/10/2024. Here, Plaintiff earned a non-discretionary bonus ("Bonus")
10 in the amount of \$1,913.88, based on company productivity and an employee's annual income.
11 Plaintiff also earned 5.80 hours of overtime pay during the same pay period. However, Defendant
12 failed to properly include the bonus payment in Plaintiff's overtime rate, as the 5.80 overtime hours
13 were paid at 1.5x Plaintiff's base hourly rate of \$30.67 per hour. Thus, Defendants' failed to include
14 Plaintiff's bonus in calculating his overtime rate.

15 33. For each overtime hour worked during the period in which Plaintiff and the class
16 members earned the additional forms of remuneration, Defendants should have (but failed to) pay
17 overtime "at a rate no less than one and one-half times the regular rate of pay for an employee" and
18 "twice the regular rate of pay" for double time hours as required by the plain language of Labor Code
19 section 510(a) and the IWC Wage Orders. Defendants committed the same "regular rate of pay"
20 violation against Plaintiff and other class members as a matter of common payroll administration and
21 company policy in a manner susceptible to common proof. This resulted in the underpayment of wages
22 to employees.

23 34. Defendants failed to comply with California's paid sick leave laws with respect to the
24 class members. Specifically, Defendants failed to provide Plaintiff and the class members with all
25 sick leave accrued. Plaintiff and the class members worked off-the-clock, overtime hours that were
26 not accounted for when calculating an employee's accrued paid sick leave.

1 35. Defendants also failed to include all remuneration into the paid sick leave hourly rate,
2 resulting in depreciated sick pay to the extent any was paid at all. Therefore, Plaintiff and other class
3 members were not awarded the total accrued sick leave time they had earned.

4 36. Defendants maintained an unlawful policy and practice of failing to pay all accrued and
5 unused vacation wages upon separation of employment at the lawful rate of pay, resulting in forfeiture
6 of vested vacation time and wages.

7 37. As described above, Defendants failed to record all of the time that Plaintiff and other
8 class members worked for Defendant and undercounted their hours worked. Consequently, Defendant
9 failed to credit the class members with all vacation time they had actually accrued. Therefore, vacation
10 wages were not paid out at the lawful rate of pay inclusive of all earnings.

11 38. Defendants failed to provide Plaintiff and class members with compliant meal periods
12 and meal period premiums. Specifically, Plaintiff and the class members routinely experienced missed,
13 late, short, and interrupted meal periods due to the high demands of the job and pressures from
14 management. For example, Plaintiff experienced non-compliant meal periods because management
15 would interrupt his lunch so he could address urgent work-related issues. Moreover, Plaintiff alleges
16 that when we worked more than 10 hours in a day, Defendants failed to provide him with a compliant
17 second meal period. As discussed above, Defendants forced Plaintiff to edit his timecard to show that
18 he took a compliant meal period, when in reality, he did not. Therefore, Plaintiff and class members
19 regularly worked through meal periods or missed them altogether.

20 39. Upon information and belief, when Defendants did not provide compliant meal periods,
21 Defendants failed to pay Plaintiff and the class members a meal period premium in violation of Labor
22 Code section 226.7. To the extent Defendants ever paid a meal period premium, Defendants violated
23 Labor Code section 226.7 because such premiums were not paid at the regular rate of compensation
24 to the class members, which should have factored in bonuses and other forms of non-excludable
25 remuneration.

26 40. Similarly, Defendants failed to provide all rest periods to which employees were
27 entitled and failed to pay rest period premiums to Plaintiff and other class members.
28

1 41. As stated above, due to the job's high demands and pressures from management,
2 Plaintiff and the class members were rarely, if at all, authorized or permitted to take all their rest
3 periods.

4 42. To the extent Defendant ever paid a rest period premium, Defendant violated Labor
5 Code section 226.7 because such premiums were not paid at the "regular rate of compensation" to
6 Plaintiff and the class members, which should have factored in bonuses and other forms of non-
7 excludable remuneration.

8 43. Defendants required Plaintiff and the class members to incur costs for work-related
9 purposes without full reimbursement. In direct consequence of their job duties, Plaintiff and the class
10 members unavoidably and necessarily incurred these losses, expenditures, costs, and as a matter of
11 policy and practice.

12 44. For example, Plaintiff worked from home and was required to supply and use his own
13 internet for work-related purposes. Defendants did not reimburse Plaintiff and the class members for
14 expenses incurred from obtaining and using their internet that were necessary for the job.

15 45. Defendants failed to pay all wages and premiums owed to class members during their
16 employment, and also failed to timely pay those amounts to departing employees upon separation of
17 employment. Defendants did not pay waiting time penalties for the late payments.

18 46. These violations create derivative liability for failure to timely pay all wages owed each
19 payday or upon separation of employment.

20 47. As a result of the foregoing issues, Defendants failed to provide accurate itemized wage
21 statements to the class members each pay period as a result of the policies and practices set forth in
22 this notice. Defendants violated Labor Code section 226(a)(1) and (5) by not listing the correct "gross
23 wages earned" or "net wages earned," as the employees earned wages and premiums that were not
24 paid, resulting in an inaccurate reflection, and recording of "gross wages earned" on those wage
25 statements.

26 48. Likewise, in violation of Labor Code section 226(a)(9), Defendants failed to state on
27 employee wage statements each pay period the applicable hourly rates in effect and the number of
28 hours worked at that rate, as Defendants failed to pay all wages and premiums owed to employees.

1 The amounts stated are instead depreciated and underpaid, resulting in an inaccurate reflection on the
2 pay stub.

3 49. Defendants violated Labor Code section 226(a)(2) by failing to accurately list
4 employees' "total hours worked," as the wage statements did not accurately include the
5 uncompensated time Plaintiff and other class members worked during their meal periods.

6 50. Because of these policies and practices set forth in this notice, including the failure to
7 accurately account for wages earned or hours worked, Defendants failed to accurately maintain records
8 in accordance with Labor Code section 1174 and the IWC Wage Orders

9 **FIRST CAUSE OF ACTION**

10 **MINIMUM WAGE VIOLATIONS**

11 **Violation of Labor Code §§ 1194, 1194.2 and 1197**

12 **(All Claims Alleged by Plaintiff and Class Members Against All Defendants)**

13 51. All outside paragraphs of this Complaint are incorporated into this section.

14 52. This cause of action is brought pursuant to the IWC Wage Orders and Labor Code
15 §§ 200, 218, 1182.12, 1194, 1194.2, 1197, 1197.1 and 1198 and the IWC Wage Orders (the "Hours
16 and Days of Work" and "Minimum Wages" sections of the applicable orders), which require non-
17 exempt employees be timely paid at least the state or local minimum wage (if higher) for each hour of
18 work, and further provide a private right of action for an employer's failure to pay all minimum wages
19 (plus liquidated damages). In addition to minimum wages, Labor Code § 200 states that "'wages'
20 includes all amounts for labor performed by employees of every description, whether the amount is
21 fixed or ascertained by the standard of time, task, piece, commission basis, or other method of
22 calculation."

23 53. Defendants willfully failed in their affirmative obligation to pay Plaintiff and class
24 members at least the lawful minimum wage for each hour worked in violation of Labor Code sections
25 1182.12, 1194, 1194.2, 1197, 1197.1 and 1198 and the IWC Wage Orders (the "Hours and Days of
26 Work" and "Minimum Wages" sections of the applicable orders), including payment at the lawful
27 local and county minimum wage ordinances in effect. As a result, Defendants are liable for all
28

1 associated damages, including liquidated damages for the minimum wage violations pursuant to Labor
2 Code § 1194.2.

3 54. Defendants' unlawful acts and omissions deprived Plaintiff and class members of
4 minimum, regular and overtime wages in amounts to be determined at trial. Plaintiff and class
5 members are entitled to recover the full amount of the unpaid wages, plus liquidated damages in an
6 amount equal to the wages unlawfully unpaid (and interest thereon), in addition to interest, attorneys'
7 fees, and costs to the extent permitted by law, including under Labor Code sections 1194 and 1194.2,
8 218.6 and any other applicable statutes.

9 **SECOND CAUSE OF ACTION**

10 **FAILURE TO PAY ALL OVERTIME WAGES**

11 **Violation of Labor Code §§ 510 and 1194**

12 55. All outside paragraphs of this Complaint are incorporated into this section.

13 56. This cause of action is brought pursuant to the IWC Wage Orders and Labor Code
14 §§ 204, 510, 558, 1194, and 1198, which require non-exempt employees be timely paid overtime
15 wages all overtime hours worked, and which further provide a private right of action for an employer's
16 failure to pay all overtime compensation for overtime hours worked.

17 57. Defendants failed in their affirmative obligation to pay Plaintiff and class members no
18 less than one and one-half times their respective "regular rate of pay" for all hours worked in excess
19 of eight hours in one day, 40 hours in one week, or the first eight hours worked on the seventh day of
20 work in any one workweek, and no less than twice their respective "regular rate of pay" for all hours
21 over 12 hours in one day and any work in excess of eight hours on any seventh day of a workweek for
22 such hours worked, in violation of Labor Code sections 204, 510, 558, 1194, and 1198 and the IWC
23 Wage Orders (the "Hours and Days of Work" sections of the applicable orders).

24 58. Plaintiff and class members are entitled to recover the full amount of the unpaid
25 overtime, in addition to interest, statutory and civil penalties, and attorneys' fees, and costs to the
26 extent permitted by law.

1 **FOURTH CAUSE OF ACTION**

2 **REST PERIOD VIOLATIONS**

3 **Violation of Labor Code §§ 226.7 and 516**

4 64. All outside paragraphs of this Complaint are incorporated into this section.

5 65. This cause of action is brought pursuant to the IWC Wage Orders and Labor Code
6 §§ 226.7 and 516, which require non-exempt employees be authorized to take complaint rest periods
7 (or rest period premiums in lieu thereof), and which further provide a private right of action for an
8 employer's failure to lawfully provide all rest periods and/or pay rest period premiums at the lawful
9 regular rate of compensation.

10 66. Defendants willfully failed in their affirmative obligation to consistently authorize and
11 permit Plaintiff and class members to receive compliant, duty-free rest periods of not less than ten
12 (10) minutes for every four hours worked (or major fraction thereof) in violation of Labor Code
13 sections 226.7, 516, 558, and 1198 and the IWC Wage Orders (the "Rest Periods" sections of the
14 applicable orders).

15 67. Further, Defendants willfully failed in their affirmative obligation to consistently pay
16 Plaintiff and class members one additional hour of pay at the respective regular rate of compensation
17 for each workday that a fully compliant rest period was not provided, in violation of Labor Code
18 sections 226.7, 516, 558, and 1198 and the IWC Wage Orders.

19 **FIFTH CAUSE OF ACTION**

20 **FAILURE TO PAY ALL PAID SICK LEAVE WAGES**

21 **Violation of Labor Code §§ 200, 218, 246 *et seq.***

22 68. All outside paragraphs of this Complaint are incorporated into this section.

23 69. Defendants knowingly and intentionally failed in their affirmative obligation to pay
24 sick leave wages to Plaintiff and a paid sick leave subclass in violation of Labor Code section 246
25 *et seq.* Paid sick leave earnings constitute wages for purposes of California wage and hour law.
26 (*Murphy v. Kenneth Cole Productions, Inc.* (2007) 40 Cal.4th 1094, 1103 ["Courts have recognized
27 that 'wages' also include those benefits to which an employee is entitled as a part of his or her
28 compensation, including money, room, board, clothing, vacation pay, and sick pay"].)

70. Labor Code section 246(l), in conjunction with Labor Code section 248 *et seq.*, 248.1, 248.2, and 248.6, in addition to the applicable County sick pay ordinances in locales worked by class members, govern how Defendants were required to calculate paid sick leave.

71. Defendants failed to pay Plaintiff and class members their paid sick leave wages at one of the lawful rates set forth in the statute or ordinance because Defendants failed to include in their sick leave calculation the additional remuneration received by Plaintiff and class members (i.e., at the regular rate of pay and/or calculated based on total wages earned).

72. Furthermore, to the extent the paid sick leave paid constitutes Covid-related paid sick leave, Defendants knowingly and intentionally failed in their affirmative obligation to pay Covid-19 Supplemental Sick Leave wages to class members at the correct accrual rate or hourly pay rate in violation of Labor Code sections 246, 248.1, 248.2, and 248 *et seq.*

73. As a result, Defendants violated the Labor Code and are liable to Plaintiff and class members for underpaid sick leave wages, in addition to interest, attorneys' fees, and costs.

SIXTH CAUSE OF ACTION

UNPAID VACATION WAGES

Violation of Labor Code §§ 201, 202, 203, and 227.3 and 1194, and 1198

74. All outside paragraphs of this Complaint are incorporated into this section.

75. This cause of action is brought by an unpaid vacation wages subclass pursuant to Labor Code §§ 200, 201, 202, 203, and 227.3 and 1194, and 1198, which require non-exempt employees be timely paid all vested vacation wages at their final rate of pay upon separation of employment, and which further provide a private right of action for an employer's timely failure to pay all vacation compensation upon termination.

76. Defendant offered Plaintiff and class members an employment contract or policy providing for the accrual of vacation and/or paid time off. Plaintiff and class members accrued vacation and/or PTO pursuant to the contract or policy.

77. Upon separation of Plaintiff and class members, Defendants willfully failed in their affirmative obligation to timely pay Plaintiff and class members all accrued but unused vacation at

1 their final rate during their employment with Defendants, in violation of Labor Code sections 201(a),
2 202(a), and 227.3.

3 78. Plaintiff and class members are entitled to recover the full amount of the accrued
4 vacation wages owed, in addition to interest, statutory and civil penalties, and attorneys' fees, and
5 costs to the extent permitted by law.

6 **SEVENTH CAUSE OF ACTION**

7 **UNTIMELY PAYMENT OF WAGES**

8 **Violation of Labor Code §§ 204, 210, 218**

9 79. All outside paragraphs of this Complaint are incorporated into this section.

10 80. This cause of action is brought pursuant to the IWC Wage Orders and Labor Code
11 §§ 204, 204b, and 210 which require non-exempt employees be timely paid all wages owed each pay
12 period, and which further provide a private right of action for an employer's failure to comply with
13 this obligation. Labor Code § 218 authorizes individuals to sue directly for wages and penalties due
14 under these sections, including Labor Code § 210(c)'s statutory late payment penalties.

15 81. Defendants willfully failed in their affirmative obligation to timely pay all wages,
16 including paid sick leave and meal and rest premiums, earned by Plaintiff and class members twice
17 during each calendar month on days designated in advance by the employer as regular paydays (for
18 employees paid on a non-weekly basis) and on the regularly-scheduled weekly payday for weekly
19 employees, if any, in violation of Labor Code sections 204 and 204b and the IWC Wage Orders (the
20 "Minimum Wages" sections of the applicable orders).

21 82. Plaintiff and class members are entitled to recover the full amount of the unpaid wages,
22 in addition to a statutory penalty in the amount of \$100 for the initial violation for each failure to pay
23 each employee and \$200 for all subsequent violations and for all willful or intentional violations for
24 each failure to pay each employee, plus 25 percent of the amount unlawfully withheld under provided
25 in Labor Code § 210, in addition to interest, attorneys' fees, and costs to the extent permitted by law.

1 **EIGHTH CAUSE OF ACTION**

2 **WAGE STATEMENT VIOLATIONS**

3 **Violation of Labor Code § 226**

4 83. All outside paragraphs of this Complaint are incorporated into this section.

5 84. This cause of action is brought by a wage statement subclass pursuant to Labor Code
6 § 226(a) which requires non-exempt employees be provided accurate itemized wage statements each
7 pay period, and which further provide a private right of action for an employer's failure to comply
8 with this obligation.

9 85. Defendants knowingly and intentionally failed in their affirmative obligation to provide
10 accurate itemized wage statements to Plaintiff and class members resulting in injury to Plaintiff and
11 class members. Specifically, the wage statements issued to Plaintiff and class members did not
12 accurately state each pay period all of the information required by Labor Code § 226(a)(1)-(9).

13 86. Defendants' unlawful acts and omissions deprived Plaintiff and class members of
14 accurate itemized wage statements, causing confusion and concealing wage and premium
15 underpayments.

16 87. As a result, Plaintiff and class members are entitled to recover the statutory penalty of
17 \$50 per employee for the initial pay period in which a violation occurred and \$100 per employee for
18 each violation in a subsequent pay period, up to an aggregate penalty of \$4,000 per employee, in
19 addition to interest, attorneys' fees, and costs to the extent permitted by law, including under Labor
20 Code section 226(e).

21 **NINTH CAUSE OF ACTION**

22 **WAITING TIME PENALTIES**

23 **Violation of Labor Code §§ 201 *et seq.***

24 88. All outside paragraphs of this Complaint are incorporated into this section.

25 89. This cause of action is brought by a waiting time subclass pursuant to Labor Code
26 §§ 201 through 203, which require an employer to timely pay all wages earned upon termination of
27 employment, and which further provide a private right of action to recover statutory waiting time
28

1 penalties each day an employer fails to comply with this obligation, up to a maximum of 30 days
2 wages.

3 90. Defendants willfully failed and continue to fail in their affirmative obligation to pay all
4 wages earned and unpaid to Plaintiff and class members immediately upon termination of employment
5 or within 72 hours thereafter for employees who did not provide at least 72 hours prior notice of his
6 or her intention to quit, and further failed to pay those sums for 30 days thereafter in violation of Labor
7 Code sections 201 through 203 and the IWC Wage Orders.

8 91. Plaintiff and class members are entitled to recover a waiting time penalty for a period
9 of up to 30 days, in addition to interest, attorneys' fees, and costs to the extent permitted by law.

10 **TENTH CAUSE OF ACTION**

11 **FAILURE TO REIMBURSE BUSINESS EXPENSES**

12 **Violation of Labor Code § 2802**

13 92. All outside paragraphs of this Complaint are incorporated into this section.

14 93. Defendants willfully failed in their affirmative obligation to reimburse Plaintiff and a
15 reimbursement subclass for all necessary expenditures, losses, expenses, and costs incurred by them
16 in direct discharge of the duties of their employment, in violation of Labor Code section 2802.

17 94. Defendants' unlawful acts and omissions deprived Plaintiff and class members of
18 lawful reimbursements for business expenses in amounts to be determined at trial. Plaintiff and class
19 members are entitled to recover the amount unreimbursed expenses of Plaintiff and class members in
20 addition to interest, attorneys' fees, and costs to the extent permitted by law, including under Labor
21 Code section 2802.

1 **ELEVENTH CASUE OF ACTION**

2 **UNFAIR COMPETITION**

3 **Violation of Business and Professions Code §§ 17200 *et seq.***

4 95. All outside paragraphs of this Complaint are incorporated into this section.

5 96. Defendants have engaged and continue to engage in unfair and/or unlawful business
6 practices in the State of California in violation of California Business and Professions Code § 17200
7 by committing the foregoing wage and hour violations alleged throughout this Complaint.

8 97. Defendants' dependence on these unfair and/or unlawful business practices deprived
9 Plaintiff and continue to deprive other class members of compensation to which they are legally
10 entitled, constitutes unfair and/or unlawful competition, and provides an unfair advantage to
11 Defendants over competitors who have been and/or are currently employing workers in compliance
12 with California's wage and hour laws. These failures constitute unlawful, deceptive, and unfair
13 business acts and practices in violation of Business and Professions Code section 17200 *et seq.*

14 98. Plaintiff is a victim of Defendants' unfair and/or unlawful conduct alleged in this
15 Complaint, and Plaintiff, as an individual and on behalf of others similarly situated, seeks full
16 restitution of the moneys as necessary and according to proof to restore all monies withheld, acquired,
17 and/or converted by Defendants pursuant to Business and Professions Code §§ 17203 and 17208.

18 99. Plaintiff does not have an adequate remedy at law for past or future violations, to the
19 extent the statute of limitations on each of the alleged causes of action do not extend to the four year
20 limitation provided under the UCL or to the extent the underlying Labor Code and IWC Wage Order
21 violations do not provide a private right of action.

22 100. Plaintiff and class members are entitled to injunctive relief against Defendants,
23 restitution, and other equitable relief to return all funds over which Plaintiff and class members have
24 an ownership interest and to prevent future damage and the public interest under Business and
25 Professions Code § 17200 *et seq.* Plaintiff and class members are further entitled to recover interest,
26

attorneys' fees, and costs to the extent permitted by law, including under Code of Civil Procedure § 1021.5.

TWELFTH CAUSE OF ACTION

CIVIL PENALTIES UNDER THE PRIVATE ATTORNEYS GENERAL ACT

Violation of Labor Code §§ 2698 *et seq.*

(By Plaintiff on Behalf of the State and the Aggrieved Employees Against All Defendants)

101. All outside paragraphs of this Complaint are incorporated into this section.

102. Plaintiff brings this cause of action as a proxy for the State of California on behalf of the following “aggrieved employees” pursuant to the Private Attorneys General Act (“PAGA”), codified as Labor Code section 2698 *et seq.*:

a. All current and former non-exempt employees who worked for Defendants in California at any time from one year prior to the postmark date of the initial PAGA notice through date of trial.

103. Plaintiff reserves the right to amend, supplement, or add to this description of the aggrieved employees, according to proof.

104. The State of California, via the Labor and Workforce Development Agency (“LWDA”), is the real party in interest in this action with respect to this cause of action. (*Kim v. Reins Int’l California, Inc.* (2020) 9 Cal. 5th 73, 81 [The “government entity on whose behalf the plaintiff files suit is always the real party in interest.”])

105. Labor Code section 2699(a) provides: “Notwithstanding any other provision of law,, any provision of this code that provides for a civil penalty to be assessed and collected by the Labor and Workforce Development Agency or any of its departments, divisions, commissions, boards, agencies, or employees, for a violation of this code, may, as an alternative, be recovered through a civil action brought by an aggrieved employee on behalf of the employee and other current or former employees against whom a violation of the same provision was committed pursuant to the procedures specified in Section 2699.3. “

1 106. Any allegations regarding violations of the IWC Wage Orders are enforceable as
2 violations of Labor Code section 1198, which states: “[t]he employment of any employee for longer
3 hours than those fixed by the order or under conditions of labor prohibited by the order is unlawful.”

4 107. Labor Code section 2699.3 sets forth the procedure for commencing an action for civil
5 penalties under the PAGA.

6 108. On or about **December 17, 2024**, Plaintiff paid the requisite PAGA filing fee and
7 provided written notice (by online electronic filing with the LWDA and by certified mail to
8 Defendants) of Defendants’ alleged Labor Code violations, including the facts and theories to support
9 the alleged violations.

10 109. A true and correct copy of Plaintiff’s written PAGA notice, entitled “Notice of Labor
11 Code Violations” is attached hereto as Exhibit 1 and incorporated by reference as though fully set
12 forth herein (the “PAGA notice”).

13 110. To date, neither Plaintiff nor Plaintiff’s counsel has received a response to Plaintiff’s
14 written PAGA notice from the LWDA.

15 111. Within 33 calendar days of the postmark date of the notice sent by Plaintiff, neither
16 Plaintiff nor Plaintiff’s counsel has received written notice by certified mail from any defendant
17 providing a description of any actions taken to cure the alleged violations.

18 112. Now that at least 65 days have passed from Plaintiff notifying Defendants of these
19 violations, without notice of cure from Defendants or notice from the LWDA of its intent to investigate
20 the alleged allegations and issue the appropriate citations to Defendants, Plaintiff exhausted all
21 prerequisites and commenced this civil action under Labor Code section 2699 *et seq.*

22 113. As set forth in the PAGA notice attached as Exhibit 1 and incorporated into this
23 Complaint, Defendants committed the following violations and are liable for all corresponding civil
24 penalties:

- 25 a. ***Unpaid Hours Worked/Minimum Wage.*** Violation of Labor Code §§ 1194,
26 1197, 1198; IWC Wage Orders.
- 27 b. ***Unpaid Overtime.*** Violation of Labor Code §§ 510, 1194, 1198; IWC Wage
28 Orders.

- c. ***Unpaid Paid Sick Leave.*** Violation of Labor Code §§ 246 through 248.7.
- d. ***Unpaid Vacation Wages.*** Violation of Labor Code § 227.3.
- e. ***Unpaid Meal Period Premium Wages.*** Violation of Labor Code §§ 226.7, 512, 1198; IWC Wage Orders.
- f. ***Unpaid Rest Period Premium Wages.*** Violation of Labor Code §§ 226.7, 516, 1198; IWC Wage Orders.
- g. ***Untimely Payment of Wages During Employment.*** Violation of Labor Code §§ 204, 204b, 210.
- h. ***Untimely Payment of Wages Upon Separation of Employment.*** Violation of Labor Code §§ 201, 202, 203, 256.
- i. ***Non-Compliant Wage Statements.*** Violation of Labor Code §§ 226, 226.3.
- j. ***Unreimbursed Employee Expenses.*** Violation of Labor Code §§ 2802, 2804.
- k. ***Failure to Maintain Accurate Records.*** Violation of Labor Code § 1174; IWC Wage Orders.

114. Plaintiff seeks to collect all recoverable civil penalties for the Labor Code violations alleged in this Complaint and the PAGA notice (including amendments thereto) against Defendants pursuant to Labor Code section 2699(a) and (f), in addition to attorneys' fees, costs, and interest to the extent permitted by law, including under Labor Code section 2699(k).

PRAYER

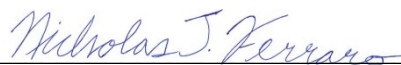
Plaintiff prays for judgment as follows:

- d. For division of class members into appropriate classes and/or subclasses according to proof;
- e. For recovery of all statutory penalties and liquidated damages;
- f. For disgorgement of all amounts wrongfully obtained to the extent permitted by law;
- g. For restitution and injunctive relief;

- 1 h. For attorneys' fees and costs of suit, including expert fees, to the extent permitted by
2 law, including (without limitation) under Labor Code §§ 218.5, 226, 1194, 2802 and
3 Code of Civil Procedure § 1021.5.;
- 4 i. For recovery of damages in amount according to proof;
- 5 j. For all recoverable pre- and post-judgment interest;
- 6 k. For this action to be maintained as a representative action under the PAGA;
- 7 l. For Plaintiff and counsel of record to be provided with all enforcement capability as if
8 the action were brought by the State of California or the California Division of Labor
9 Enforcement;
- 10 m. For recovery of all civil penalties and other recoverable amounts under the PAGA;
- 11 n. For reasonable attorneys' fees and costs of suit, including expert fees, to the extent
12 permitted by law, associated with the PAGA claims pursuant to Labor Code § 2699,
13 and Code of Civil Procedure section 1021.5 and any other applicable sections; and
- 14 o. For such other relief the Court deems just and proper.

Dear LWDA Officer and Company Representatives:

This letter serves as written notice under Labor Code section 2699.3 on behalf of **ARNULFO MARQUEZ** (“Plaintiff(s)”) and all other “aggrieved employees” of the following “Defendant(s)”:

CORELATION, INC.

Defendant(s) shall mean and include the foregoing in addition to any other related employer entities, individuals under Labor Code sections 558 and 558.1, and all others who may be later added upon further investigation and discovery as liable employers.

This office serves as legal counsel for Plaintiff. If the California Labor and Workforce Development Agency (“LWDA”) does not investigate the facts, allegations, and violations set forth in this notice within the statutorily prescribed 65-day period under Labor Code section 2699.3, Plaintiff intends to commence a civil action against Defendants as a proxy and agent of the State of California under the Private Attorneys General Act (“PAGA”). “PAGA allows an ‘aggrieved employee’—a person affected by at least one Labor Code violation committed by an employer—to pursue penalties for all the Labor Code violations committed by that employer.” *Huff v. Securitas Security Services USA, Inc.* (2018) 23 Cal. App. 5th 745, 751; *Kim v. Reins International California, Inc.* (2020) 9 Cal. 73, 79. Plaintiff maintains standing to pursue these claims against Defendants as an aggrieved employee.

Through this notice, Plaintiff requests that Defendants complete an internal investigation and audit of the wage and hour and employment practices at issue and make a good faith effort to

correct any violations. Plaintiff attempts to identify the non-compliant policies and practices affecting the aggrieved employees so that the parties may resolve the underlying damages and penalties in judgment or settlement approved by the Superior Court of California under Labor Code section 2699(s). Defendants are notified that any attempt to resolve this case should be conducted in coordination with Plaintiff's counsel to protect the interests of Plaintiff, the aggrieved employees, and the State of California via the LWDA. Plaintiff advises Defendants this letter should be also considered a reasonable attempt at settlement of this matter, subject to an exchange of additional documents and information. *Graham v. Daimler Chrysler Corp.* (2004) 24 Cal. 4th 553, 561.

- BACKGROUND -

Defendants employed Plaintiff during the PAGA Period in the position of Integration Analyst from about April 2021 to December 2024. During their employment Plaintiff and the other aggrieved employees were subject to the wage and hour and employment protections set forth in the California Labor Code and IWC Wage Orders.

Through this notice, Plaintiff informs the LWDA of the Labor Code violations set forth herein. The “aggrieved employees” include Plaintiff and the following individuals:

All current and former non-exempt employees who worked for Defendants in the State of California during one-year period preceding the date of this notice through the current date and the date of trial in any pending action (the “aggrieved employees” and the “PAGA Period”).

Plaintiff reserves the right to expand or narrow the definition of the “aggrieved employees” in the forthcoming civil action. Furthermore, Plaintiff seeks all recoverable civil penalties for Defendants’ violations and reserves the right to supplement this notice as further investigation is completed and further facts, witnesses, and violations are uncovered.

- PAGA CLAIMS -

Unpaid Hours Worked/Minimum Wage Violation of Labor Code §§ 1194, 1197, 1198; IWC Wage Orders

Defendants violated Labor Code sections 1194, 1197, and 1198, along with the California Minimum Wage Order, the applicable local minimum wage ordinances, and the “Hours and Days of Work” and “Minimum Wages” sections of the applicable IWC Wage Orders with respect to the aggrieved employees.

Labor Code section 1194 renders it unlawful for an employee to receive less than the legal minimum wage for hours worked in California. Labor Code section 1197 further mandates that “[t]he minimum wage for employees fixed by the commission is the minimum wage to be paid to employees, and the payment of a lower wage than the minimum so fixed is unlawful.”

Labor Code section 1198 renders “employment of any employee for longer hours than those fixed by the order or under conditions of labor prohibited by the [IWC Wage Orders]” unlawful. The California Minimum Wage Order and the applicable sections of the IWC Wage Orders further require payment of minimum wages for all hours worked. The “Minimum Wages” sections of the applicable IWC Wage Order provide that “[e]very employer shall pay to each employee, on the established payday for the period involved, not less than the applicable minimum wage for all hours worked in the payroll period, whether the remuneration is measured by time, piece, commission, or otherwise.” The foregoing California wage laws require payment of “not less than the applicable minimum wage *for all hours worked* in the payroll period” and California law does not allow averaging of pay over the hours worked in the pay period, even if the total pay results in an average above the minimum wage. *Armenta v. Osmose, Inc.* (2005) 135 Cal. App. 3d 314, 324.

Defendants failed to pay Plaintiff and the aggrieved employees at the lawful minimum wage rate for all hours worked, resulting in unpaid minimum wages.

Plaintiff alleges that Defendants maintained the unlawful policy and practice of editing Plaintiff’s and, on information and belief, other aggrieved employees’ time records to show fewer hours worked on their timecards and avoid paying all overtime pay and meal period premiums. Specifically, Defendants’ required Plaintiff to modify his lunchtime on his timesheet from 30 minutes to one hour, when he was only able to take one 30-minute meal period. Plaintiff manually inserts his clock in time on the time sheet, but those punch times must be approved by management before they are submitted. An illustrative example of this violation is shown below:

Extract of Plaintiff’s time records from 11/02/2024 to 11/05/2024.

Here, Plaintiff's time records indicate that he took a meal period for exactly one hour from 11/02/2024 to 11/05/2024. However, Plaintiff alleges that in order for these time records to get approved, his supervisors forced him to change his original lunch time from 30 minutes to one hour, or else his timesheet would not get approved. In fact, on 11/07/2024, Plaintiff received an email from his supervisor directing him to change his timecard to reflect that he took an hour lunch, when he did not.

Due to this time-shaving practice, all hours worked were not directly compensated, resulting in minimum wage violations. Defendants' pattern of editing employee's time records resulted in an underpayment of regular and overtime wages to Plaintiff and the aggrieved employees. These revisions were made without employees' consent. Plaintiff and the aggrieved employees were deprived of regular and overtime wages each time Defendant altered their clock-out time and overall records.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unpaid Overtime **Violation of Labor Code §§ 510, 1194, 1198; IWC Wage Orders**

Defendants violated Labor Code sections 510, 1194, and 1198, along with the "Hours and Days of Work" sections of the applicable IWC Wage Orders with respect to the aggrieved employees.

Labor Code section 510 requires "[a]ny work in excess of eight hours in one workday and any work in excess of 40 hours in any one workweek and the first eight hours worked on the seventh day of work in any one workweek shall be compensated at the rate of no less than one and one-half times the regular rate of pay for an employee;" and "any work in excess of 12 hours in one day shall be compensated at the rate of no less than twice the regular rate of pay for an employee;" and "any work in excess of eight hours on any seventh day of a workweek shall be compensated at the rate of no less than twice the regular rate of pay of an employee." Labor Code section 1194 renders it unlawful for an employee to receive less than the legal overtime rate for overtime hours worked in California. Labor Code section 1198 renders "employment of any employee for longer hours than those fixed by the order or under conditions of labor prohibited by the [IWC Wage Orders]" unlawful. The IWC Wage Orders further require payment of overtime wages for all overtime hours worked, including the "Hours and Days of Work" sections.

Defendants failed to pay Plaintiff and the aggrieved employees overtime wages and the lawful rate of pay for overtime hours worked, resulting in unpaid overtime wages.

First, as a result of Defendants editing Plaintiff's and, on information and belief, the aggrieved employees time records to include false meal periods, Defendants failed to compensate

Plaintiff and the aggrieved employees for all overtime hours worked. Each time this practice resulted in unpaid work over 8 hours in a day or 40 hours in a week, this resulted in unpaid overtime.

Second, Defendants failed to pay overtime at the regular rate of pay. Plaintiff and the aggrieved employees earned overtime in the same pay period they earned bonuses or other non-excludable remuneration, which Defendants did not include in the regular rate of pay. Below is an example of Defendants' failure to pay the overtime at the regular rate of pay.

Here, Plaintiff earned a non-discretionary bonus ("Bonus") in the amount of \$1,913.88, based on company productivity and an employee's annual income. Plaintiff also earned 5.80 hours of overtime pay during the same pay period. However, Defendant failed to properly include the bonus payment in Plaintiff's overtime rate, as the 5.80 overtime hours were paid at 1.5x Plaintiff's base hourly rate of \$30.67 per hour. Thus, Defendants' failed to include Plaintiff's bonus in calculating his overtime rate.

For each overtime hour worked during the period in which Plaintiff and the aggrieved employees earned the additional forms of remuneration, Defendants should have (but failed to) pay overtime “at a rate no less than ***one and one-half times the regular rate of pay*** for an employee” and “twice the regular rate of pay” for double time hours as required by the plain language of Labor Code section 510(a) and the IWC Wage Orders. Defendants committed the same “regular rate of pay” violation against Plaintiff and other aggrieved employees as a matter of common payroll administration and company policy in a manner susceptible to common proof. This resulted in the underpayment of wages to employees.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unpaid Paid Sick Leave **Violation of Labor Code §§ 246 through 248.7**

Defendants violated Labor Code sections 246 through 248.7 with respect to the aggrieved employees.

Labor Code section 246 requires employers to provide paid sick leave to its workforce on the terms set forth in the statute. Employers must comply with the accrual, use, and notice provisions of Labor Code sections 246, 246.5, 247, and must further ensure that they maintain the paid sick leave records required by Labor Code section 247.5. Employers have the option of providing 24 hours of paid sick leave to employees or to allow employees to accrue paid sick leave each pay period. If an employer chooses the accrual method, employees must accrue sick leave at a rate of one hour for every thirty hours worked in a given pay period as set forth in Labor Code section 246(b)(1). Under the accrual method, employees must begin accruing paid sick leave at the commencement of employment.

Employers must pay sick leave in accordance with one of the three permissible methods provided in Labor Code section 246(l): (1) “the same manner as the regular rate of pay for the workweek;” (2) “by dividing the employee’s total wages, not including overtime premium pay, by the employee’s total hours worked in the full pay periods of the prior 90 days;” or (3) “for exempt employee ... in the same manner as the employer calculates wages for other forms of paid leave time.” Labor Code sections 248.6 and 248.7 similarly require paid sick leave to be paid at a regular rate-based calculation in excess of the base hourly rate and at the lawful accrual rate.

Under Labor Code section 246(i), employers must provide employees “with written notice of the amount of paid sick leave available ... for use on either the employee’s itemized wage statement ... or in a separate writing provided on the designated pay date with the employee’s payment of wages.”

Defendants failed to comply with California's paid sick leave laws with respect to the aggrieved employees.

Defendants failed to comply with California's paid sick leave laws with respect to the aggrieved employees. Defendant failed to provide Plaintiff and the aggrieved employees with all sick leave accrued. Plaintiff and the aggrieved employees worked off-the-clock, overtime hours that were not accounted for when calculating an employee's accrued paid sick leave. Defendants also failed to include all remuneration into the paid sick leave hourly rate, resulting in depreciated sick pay to the extent any was paid at all. Therefore, Plaintiff and other aggrieved employees were not awarded the total accrued sick leave time they had earned.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unpaid Vacation Wages
Violation of Labor Code § 227.3

Defendants violated Labor Code section 227.3 with respect to the aggrieved employees.

Labor Code section 227.3 requires "whenever a contract of employment or employer policy provides for paid vacations, and an employee is terminated without having taken off his vested vacation time, all vested vacation shall be paid to him as wages at his final rate in accordance with such contract of employment or employer policy respecting eligibility or time served; provided, however, that an employment contract or employer policy shall not provide for forfeiture of vested vacation time upon termination."

Defendants maintained an unlawful policy and practice of failing to pay all accrued and unused vacation wages upon separation of employment at the lawful rate of pay, resulting in forfeiture of vested vacation time and wages. As described above, Defendant failed to record all of the time that Plaintiff and other aggrieved employees worked for Defendant and undercounted their hours worked. Consequently, Defendant failed to credit the aggrieved employees with all vacation time they had actually accrued. Therefore, vacation wages were not paid out at the lawful rate of pay inclusive of all earnings.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unpaid Meal Period Premium Wages
Violation of Labor Code §§ 226.7, 512, 1198; IWC Wage Orders

Defendants violated Labor Code sections 226.7, 512, and 1198, along with the related sections of the IWC Wage Orders with respect to the aggrieved employees.

Labor Code section 512 and the IWC Wage Orders require that employers provide an uninterrupted 30-minute meal period after no more than five hours of work and a second meal period after no more than 10 hours of work. *See Brinker Restaurant Corp. v. Superior Court* (2012) 53 Cal. 4th 1004, 1049. Labor Code section 226.7 requires that if a meal period is late, missed, short, or interrupted, the employer must pay one additional hour of pay at the employee's "regular rate" of compensation. *Ferra v. Loews Hollywood Hotel, LLC* (2021) 11 Cal. 5th 858, 862 ("We hold that the terms are synonymous: "regular rate of compensation" under section 226.7(c), like "regular rate of pay" under section 510(a), encompasses all nondiscretionary payments, not just hourly wages"). "[T]ime records showing noncompliant meal periods raise a rebuttable presumption of meal period violations, including at the summary judgment stage." *Donohue v. AMN Services, LLC* (2021) 11 Cal. 5th 58, 61. Labor Code section 1198 renders "employment of any employee for longer hours than those fixed by the order or under conditions of labor prohibited by the [IWC Wage Orders]" unlawful. The IWC Wage Orders, including Section 11 (Meal Periods), further require one uninterrupted 30-minute meal period after no more than five hours of work and a second meal period after no more than 10 hours of work and an additional hour of pay at the employee's regular rate of compensation for each workday that a compliant meal period is not provided. Pursuant to Section 11(A) of the IWC Wage Orders, the California Supreme Court has held that the on-duty meal period exception is "exceedingly narrow" and applies only when (1) "the nature of the work prevents the employee from being relieved of all duty" and (2) *both* "the employer and employee have agreed, in writing, to the on-duty meal period." *Augustus v. AMB Security Services, Inc.* (2016) 2 Cal. 5th 257, 266-276 (emphasis added). If these two requirements are not met, then the employer owes the employee one hour of premium pay for each non-compliant meal period taken under the purported on-duty meal arrangement. *Naranjo v. Spectrum Security Services, Inc.* (2019) 40 Cal. 5th 444, 459.

Plaintiff and the aggrieved employees routinely experienced missed, late, short, and interrupted meal periods due to the high demands of the job and pressures from management. Specifically, Plaintiff experienced non-compliant meal periods because management would interrupt his lunch so he could address urgent work-related issues. Moreover, Plaintiff alleges that when we worked more than 10 hours in a day, Defendants failed to provide him with a compliant second meal period. As discussed above, Defendants forced Plaintiff to edit his timecard to show that he took a compliant meal period, when in reality, he did not. Therefore, Plaintiff and other employees regularly worked through meal periods or missed them altogether.

Upon information and belief, when Defendants did not provide compliant meal periods, Defendants failed to pay Plaintiff and the aggrieved employees a meal period premium in violation of Labor Code section 226.7. To the extent Defendants ever paid a meal period

premium, Defendant violated Labor Code section 226.7 because such premiums were not paid at the regular rate of compensation to the aggrieved employees, which should have factored in bonuses and other forms of non-excludable remuneration.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unpaid Rest Period Premium Wages
Violation of Labor Code §§ 226.7, 516, 1198; IWC Wage Orders

Defendants violated Labor Code sections 226.7, 516, and 1198, and the related sections of the IWC Wage Orders with respect to Plaintiff and the aggrieved employees.

Labor Code sections 226.7 and 516 and the IWC Wage Orders require that employers authorize and permit an uninterrupted 10-minute rest period for each four-hour period (or major fraction thereof) that an employee works. Labor Code section 226.7 requires that if a rest period is non-compliant, the employer must pay one additional hour of pay at the employee's "regular rate" of compensation. *Ferra v. Loews Hollywood Hotel, LLC* (2021) 11 Cal. 5th 858, 862 ("We hold that the terms are synonymous: "regular rate of compensation" under section 226.7(c), like "regular rate of pay" under section 510(a), encompasses all nondiscretionary payments, not just hourly wages"). Labor Code section 1198 renders "employment of any employee for longer hours than those fixed by the order or under conditions of labor prohibited by the [IWC Wage Orders]" unlawful. The IWC Wage Orders, including Section 12 (Rest Periods), further require one uninterrupted 10-minute rest period for each four-hour period (or major fraction thereof) worked and an additional hour of pay at the employee's regular rate of compensation for each workday that a compliant rest period is not authorized or permitted.

Defendants failed to provide all rest periods to which employees were entitled and failed to pay rest period premiums to Plaintiff and other aggrieved employees. As stated above in the "Unpaid Meal Period Premium" section, due to the job's high demands and pressures from management, Plaintiff and the aggrieved employees were rarely, if at all, authorized or permitted to take all their rest periods. To the extent Defendant ever paid a rest period premium, Defendant violated Labor Code section 226.7 because such premiums were not paid at the "regular rate of pay" to Plaintiff and the aggrieved employees, which should have factored in bonuses and other forms of non-excludable remuneration.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Untimely Payment of Wages During Employment
Violation of Labor Code §§ 204, 204b, 210

Defendants violated Labor Code sections 204 and/or 204b and 210, as applicable, with respect to Plaintiff and the aggrieved employees.

Labor Code section 204(a) requires payment of “all wages” for non-exempt employees at least twice each calendar month. Labor Code section 204(d) states all wages due must be paid “not more than seven calendar days following the close of the payroll period.” Labor Code section 204b applies to employees paid on a weekly basis and also requires the payment for all labor within the required pay periods. Labor Code section 210 provides “every person who fails to pay the wages of an employee as provided in Section ... 204 ... shall be subject to a civil penalty” of \$100 for an initial violation and \$200 plus 25% of the amount unlawfully withheld for a subsequent violation.

Because Defendants failed to pay all wages and premiums in each pay period in which such wages were earned at the lawful rate, Defendants violated Labor Code section 204 and/or 204b (for weekly employees, as applicable). Defendants violated Labor Code sections 204 and 204b by failing to pay all wages and premiums owed on the regular pay days scheduled each pay period within seven calendar days of the close of the payroll period, as a result of the policies and practices set forth in this notice. Indeed, Defendants failed to pay all premiums, overtime, regular, sick leave, and other earnings on time each payday.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Untimely Payment of Wages Upon Separation of Employment
Violation of Labor Code §§ 201, 202, 203, 256

Defendants violated Labor Code sections 201, 202, and 203 with respect to the aggrieved employees by failing to pay all wages and premiums owed upon termination of employment.

Labor Code section 201 requires that if an employer fires an employee, the wages must be paid immediately. Labor Code section 202 requires that if an employee quits without providing 72 hours’ notice, his or her wages must be paid no later than 72 hours thereafter. Labor Code section 202 states that if an employee provides 72 hours’ notice, the final wages are payable upon his or her final day of employment. Labor Code section 203 requires an employer who fails to comply with Labor Code sections 201 or 202 to pay a waiting time penalty for each employee, up to a period of 30 days additional compensation.

Defendants failed to pay all wages and premiums owed to aggrieved employees during their employment as set forth in this notice, and also failed to timely pay those amounts to departing employees upon separation of employment. Defendants did not pay waiting time penalties

for the late payments. As a result, Defendants violated Labor Code sections 201, 202, and 203.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Non-Compliant Wage Statements **Violation of Labor Code §§ 226, 226.3**

Defendants violated Labor Code sections 226(a) and 226.3 with respect to the aggrieved employees by failing to furnish itemized wage statements each pay period that accurately list all information required by Labor Code section 226(a)(1) through (9).

Labor Code section 226(a) requires an employer to furnish wage statements to employees semimonthly or at the time of each payment of wages, “an accurate itemized statement in writing showing:” (1) gross wages earned, (2) total hours worked, (3) the number of piece rate units earned and applicable piece-rate in effect, (4) all deductions, (5) net wages earned, (6) the inclusive dates of the pay period, (7) the name of the employee and last four digits of SSN or an EIN, (8) the name and address of the legal name of the employer, and (9) all applicable hourly rates in effect during the pay period and the number of hours worked at each hourly rate by the employee.

Defendants failed to provide accurate itemized wage statements to the aggrieved employees each pay period as a result of the policies and practices set forth in this notice. Defendants violated Labor Code section 226(a)(1) and (5) by not listing the correct “gross wages earned” or “net wages earned,” as the employees earned wages and premiums that were not paid, resulting in an inaccurate reflection, and recording of “gross wages earned” on those wage statements. Likewise, in violation of Labor Code section 226(a)(9), Defendants failed to state on employee wage statements each pay period the applicable hourly rates in effect and the number of hours worked at that rate, as Defendants failed to pay all wages and premiums owed to employees. The amounts stated are instead depreciated and underpaid, resulting in an inaccurate reflection on the pay stub.

Defendants violated Labor Code section 226(a)(2) by failing to accurately list employees’ “total hours worked,” as the wage statements did not accurately include the uncompensated time Plaintiff and other aggrieved employees worked during their meal periods.

Plaintiff and other aggrieved employees cannot promptly and easily determine from the wage statement alone the wages paid or earned without reference to other documents or information. Indeed, these wage statement violations are significant because they sow confusion among Plaintiff and other aggrieved employees with respect to what amounts were owed and paid, at what rates, the number of hours worked, and how those amounts were or

should be calculated. The wage statements reflect a false statement of earnings and concealed the underlying problems and underpayments of employee wages.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Unreimbursed Employee Expenses **Violation of Labor Code §§ 2802, 2804**

Defendants violated Labor Code section 2802 with respect to the aggrieved employees by failing to reimburse the aggrieved employees for all necessary expenditures or losses incurred as part of their job duties.

Labor Code section 2802 requires an employer to “indemnify his or her employee for all necessary expenditures or losses incurred by the employee in direct consequence of the discharge of his or her duties, or of his or her obedience to the directions of the employer, even though unlawful, unless the employee, at the time of obeying the directions, believed them to be unlawful.” *See, e.g., Espinoza v. West Coast Tomato Growers, LLC*, 2016 WL 4468175 at *4, n.2 (S.D. Cal. Aug. 24, 2016, No. 14-CV-2984 W (KSC)).

Labor Code section 2804 affirms that “[a]ny contract or agreement, express or implied, made by any employee to waive the benefits of this article or any part thereof, is null and void, and this article shall not deprive any employee or his personal representative of any right or remedy to which he is entitled under the laws of this State.”

Defendants required Plaintiff and the aggrieved employees to incur costs for work-related purposes without full reimbursement. In direct consequence of their job duties, Plaintiff and the aggrieved employees unavoidably and necessarily incurred these losses, expenditures, costs, and as a matter of policy and practice. For example, Plaintiff worked from home and was required to supply and use his own internet for work-related purposes. Defendants did not reimburse Plaintiff and the aggrieved employees for expenses incurred from obtaining and using their internet that were necessary for the job.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Failure to Maintain Accurate Records
Violation of Labor Code § 1174; IWC Wage Orders

Defendants violated Labor Code sections 1174 and the IWC Wage Orders by failing to maintain accurate employee payroll records with respect to Plaintiff and other aggrieved employees.

Labor Code section 1174 requires that employers maintain accurate “payroll records showing the hours worked daily by and the wages paid to, and the number of piece-rate units earned by and any applicable piece rate paid to, employees employed at the respective plants or establishments.” Section 7(A) of the IWC Wage Orders, which may be enforced through Labor Code section 1198, mandates similar recordkeeping obligations.

Because of the policies and practices set forth in this notice, including the failure to accurately account for wages earned or hours worked, Defendants failed to accurately maintain records in accordance with Labor Code section 1174 and the IWC Wage Orders.

As a result, Plaintiff may recover civil penalties as an individual and on behalf of the State of California and the aggrieved employees, up to the maximum amount allowed as set forth under the Labor Code.

Attorneys’ Fees and Costs
Labor Code § 2699(k)(1)

Plaintiff has been compelled to retain the services of counsel to protect the interests of other aggrieved employees and the State of California. Plaintiff continues to incur attorneys’ fees and costs, which are recoverable under California law, including Labor Code section 2699(k)(1).

- LITIGATION HOLD NOTICE -

This letter imposes a duty upon all defendants and their respective employees, officers, directors, executives, attorneys, human resource and payroll personnel, accountants, and other agents to preserve all physical and electronic evidence, including electronically stored information and emails, which relate to the employment of Plaintiff and the aggrieved employees specified in this notice. Evidence includes, but is not limited to, Defendants’ written employment and payroll policies and handbooks; the aggrieved employees’ personnel files and payroll records, such as paystubs, time records, wage statements, compensation reports, as well as the underlying electronically data in Excel or similar format. Memoranda and internal and external correspondence relating to the subject matter of this notice shall also be maintained. Failure to preserve and retain relevant evidence may constitute spoliation of evidence and result in an adverse inference or sanctions.

If you have any questions regarding the scope of your obligations to preserve evidence, please consult your legal counsel and always err on the side of caution. Periodic or regularly

scheduled purges or deletions of information covered by this hold must be suspended immediately.

- CONCLUSION -

If the LWDA does not pursue enforcement, Plaintiff intends to bring representative claims on behalf of the State of California and the aggrieved employees seeking civil penalties for violations of the Labor Code and the IWC Wage Orders, along with attorneys' fees, costs, interest, and other appropriate relief.

Please advise if the LWDA intends to investigate any of the factual or legal allegations set forth in this notice. Defendants may contact Plaintiff's counsel with any questions regarding this letter or the forthcoming lawsuit.
