1 **TO ALL THE PARTIES AND THEIR RESPECTIVE ATTORNEYS OF RECORD:**

2 YOU ARE HEREBY NOTIFIED THAT at 9:00 a.m. on December 19, 2025 in
3 Department 23 at the above entitled Court before the Honorable Jill H. Talley, Plaintiff Mina
4 Parwani (“Plaintiff”) will apply for an order: (1) preliminarily approving the proposed
5 settlement of this class action with Defendant Sacramento Chinese Community Service
6 Center (“Defendant”); (2) for settlement purposes only, conditionally certifying the Class,
7 which is comprised of “all individuals who are or previously were employed by Defendant
8 in California and classified as a non-exempt employee at any time during the Class Period”,
9 which is August 14, 2020 through September 21, 2025; (3) provisionally appointing Plaintiff
10 as the representative of the Class; (4) provisionally appointing Blumenthal Nordrehaug
11 Bhowmik De Blouw LLP as Class Counsel; (5) approving the form and method for
12 providing class-wide notice; (6) directing that notice of the proposed settlement be given to
13 the class; (7) appointing ILYM Group, Inc. as Administrator, and (8) scheduling a final
14 approval hearing date, proposed for May 22, 2026, which date is at least 120 days from
15 preliminary approval, to consider Plaintiff’s motion for final approval of the settlement and
16 for approval of attorneys’ fees and expenses.

17 This unopposed motion for preliminary approval of the class settlement is brought
18 pursuant to California Rules of Court, rule 3.769. Plaintiff’s motion will be based on this
19 notice of motion and motion, the accompanying memorandum of points and authorities, the
20 Declaration of Kyle Nordrehaug, the Declaration of the Plaintiff, the Class Action and
21 PAGA Settlement Agreement (“Agreement”) between the Parties, and the complete files and
22 records in this action. Because all Parties have agreed to the proposed class settlement, this
23 motion is not opposed by Defendant.

24 Pursuant to Local Rule 1.06 (A), the court will make a tentative ruling on the merits
25 of this matter by 2:00 p.m., the court day before the hearing. The complete text of the
26 tentative ruling may be downloaded off the court's website. If the party does not have online
27 access, they may call the dedicated phone number for the department as referenced in the
28 local telephone directory between the hours of 2:00 p.m. and 4:00 p.m. on the court day

1 before the hearing and receive the tentative ruling. If you do not call the court and the
2 opposing party by 4:00 p.m. the court day before the hearing, no hearing will be held.
