YOU ARE HEREBY NOTIFIED THAT at 8:30 a.m. on March 19, 2026 in
Department S25 at the Governor George Deukmejian Courthouse - Long Beach in the above
entitled Court before the Honorable Nicole M. Heeseman, Plaintiff Sherry Rumph

1 (“Plaintiff”) will apply for an order: (1) preliminarily approving the proposed settlement of
2 this class action with Defendant Sedgwick Claims Management Services, Inc.
3 (“Defendant”); (2) for settlement purposes only, conditionally certifying the Class, which is
4 comprised of “all individuals who are or previously were employed by Defendant as Field
5 Case Managers and who were classified as exempt from overtime wages in California at any
6 time during the Class Period”, which is May 24, 2020 through August 24, 2025; (3)
7 provisionally appointing Plaintiff as the representatives of the Class; (4) provisionally
8 appointing Blumenthal Nordrehaug Bhowmik De Blouw LLP as Class Counsel; (5)
9 approving the form and method for providing class-wide notice; (6) directing that notice of
10 the proposed settlement be given to the class; (7) appointing Apex Class Action LLC as the
11 Administrator, and (8) scheduling a final approval hearing date, proposed for August 13,
12 2026, which is 120 days from preliminary approval, to consider Plaintiff’s motion for final
13 approval of the settlement and for approval of attorneys’ fees, expenses and service award.

14 This unopposed motion for preliminary approval of the class settlement is brought
15 pursuant to California Rules of Court, rule 3.769. Plaintiff’s motion will be based on this
16 notice of motion and motion, the accompanying memorandum of points and authorities, the
17 Declaration of Kyle Nordrehaug, the Declaration of the Plaintiff, the Class Action and
18 PAGA Settlement Agreement (“Agreement”) between the Parties, and the complete files and
19 records in this action. Because all Parties have agreed to the proposed class settlement, this
20 motion is not opposed by Defendant.
