7 PAGA Settlement, and (2) Entry of the Final Approval Order and Judgment.

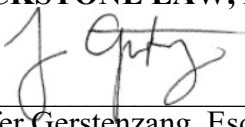
8 This Motion is brought in accordance with the Preliminary Approval Order dated May 5,
