1 **[PROPOSED] ORDER**

2 The Motion for Approval of Representative Action Settlement (“Motion”) came before this
3 Court on TBD, the Honorable Stephen P. Feccero, presiding. The Court, having considered the
4 papers submitted in support of the motion of the parties, **HEREBY ORDERS THE**
5 **FOLLOWING:**

6 Having considered Plaintiff’s Motion, and all legal authorities and documents submitted
7 in support thereof, including the PAGA Settlement Agreement (“Agreement”), attached to the
8 Szamet Declaration as Exhibit “1”, and good cause appearing, IT IS HEREBY ORDERED that
9 Plaintiffs’ Motion is GRANTED, subject to the following findings and orders:

- 10 1. The Court finds the Settlement fair and reasonable.
- 11 2. The Court approves the Gross Settlement Amount of \$794,000.00
- 12 3. The Court approves the PAGA Penalties in the amount of \$492,973.00.
- 13 4. The Court approves 75% of the PAGA Penalties being allocated to the LWDA in
14 the amount of \$369,729.75.
- 15 5. The Court directs that the remaining 25% of the PAGA Penalties, in the amount
16 of \$123,243.25 shall be allocated to the Aggrieved Employees.
- 17 6. The Court approves PAGA Counsel’s request for reimbursement of case costs in
18 the amount of \$15,810.33 and attorneys’ fees in the amount of \$264,666.67.
- 19 7. The Court approves the settlement administration costs of \$10,550.00.
- 20 8. The Court approves the enhancement awards for Plaintiffs, in the amount of
21 \$5,000.00 each, to Plaintiff KERRY HURLEY and Plaintiff LILI-ANN
22 BOYENS.
- 23 9. Pursuant to C.C.P §664.6, the Court shall have and retain continuing jurisdiction
24 over this action and the Parties and the Aggrieved Employees including after the
25 entry of this Order, to the fullest extent necessary to interpret, enforce and
26 effectuate the terms and intent of the Settlement Agreement and this Order.
